HEREBY DECIDES AS FOLLOWS.

Article 1: That the enterprise **ETS NJANKA CONSTRUCTION**, P.O Box 5185 Bamenda, Tel: 675 345 563 is awarded the contract **N°004/C/BCC/C2D-RC2/LCU/ENG/2020: LOT 1** for the construction of thirteen (13) pedestrian bridges in Bamenda in five (5) Lots, worth **twenty-seven million five hundred and eighty-nine thousand nine hundred and eighty-five (27 589 985) Francs CFA** inclusive of value added tax.

Article 2: That the enterprise **ETS NJANKA CONSTRUCTION** will execute the works in **eight (8) calendar months** as from the date of notification of the service order to start the works.

Article 3: That the drafting and the formatting of the documents constituting this contract are ensured by the Contracting Authority and the reproduction of the present contract in seven (7) subscribed copies is at the charges of the Contractor.
