## **HEREBY ORDERS AS FOLLOWS:**

ARTICLE 1. - The Model Tender File for the award of results based-roads contracts is hereby rendered enforceable and attached hereto. These contracts are intended for the execution of management and maintenance works and services by Service Level (GENIS) of certain roads of the national network.

ARTICLE 2.-The use of this Model Tender File shall be mandatory for the award of all GENIS contracts, failing which the procedure shall be considered null and void.

ARTICLE 3. - The Public Contracts Regulatory Agency shall be responsible for disseminating this Model Tender File to stakeholders of the public contracts system.

ARTICLE 4. - This order shall be registered, published according to the procedure of urgency and inserted in the Official Gazette in English and French.
