It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for the construction of warehouses within the production basins in the North West Region.
3. The Grassfield Support Project for Rural Infrastructures and Participatory Development (GRASSFIELD II) now invites sealed bids from eligible bidders for the construction of rice warehouses in Mbaw/Mbonso and Gayama production basin.
