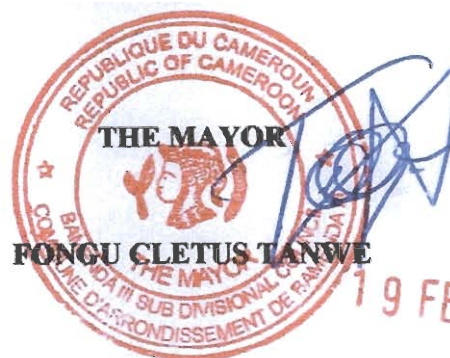
**HEREBY DECIDES AS FOLLOWS**

**Article 1.** That, **ETS SAMOUA ROGER , TEL: 677 852 150** is awarded the contract for the Control of the Construction of a Market at Ntase in Bamenda III Municipality Mezam Division, worth **Nineteen Million Six Hundred and Fourteen Thousand Two Hundred and Forty (19,614,240) cfa**, all taxes inclusive.

**Article 2.** That the above mentioned will realise the work within eight (08) months as from the date of notification of Service Order to start the work.

**Article 3.** That the Bamenda III Council Tender's Board in close relationship with the Director General of ETS **SAMOUA ROGER** and **FEICOM Engineer-NWR** are charged with the drafting of the Jobbing Order related to this contract.
