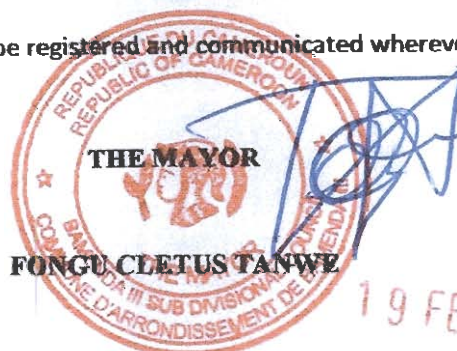
HEREBY DECIDES AS FOLLOWS

Article 1. That, **FORBAH AND SONS ENTERPRISE** is awarded the contract for the Construction of a Reinforced concrete Water Tank, An Office Block. And a Fence at Menteh in Bamenda III Municipality Mezam Division. .ion, worth **Thirty Nine Million Nine Hundred and Ninety Nine Thousand Four Hundred and Thirty Six (39,999,436) francs cfa**, all taxes inclusive.
