10 BID BOND: Each bidder must include in his administrative documents for each lot, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of *One Hundred and Sixty Thousand (160,000) francs CFA*, and valid for fifteen (1)5 days from the date of publication of the results of award. For unsuccessful bidders, the BID BOND must be withdrawn within30 days from the date of end of validity of bids. These documents must be less than three (3) months old or established after the signing of the tender notice. Any bid not in conformity with the prescriptions of the Tender File shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Minister in charge of Finance or the non-respect of the models of the TENDER file shall lead to the rejection of the bid.

12 OPENING OF BIDS: The bids shall be opened in a single phase, in the conference hall of the Nkambe Council Internal Tenders Board, on 11:00 a.m. Only bidders or their authorized representatives having a perfect knowledge of the file may attend the bid opening session.
