1. *This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in UNDB online AFDB517-08/14 of 7/08/2014 on-line and on the African Development Bank Group's Internet Website.*
2. *The Government of Cameroon has received a loan and grant from the African Development Bank in various currencies to finance the cost of the Grassfield Support Project for Rural Infrastructures and Participatory Development (GRASSFIELD II). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for the construction of water supply schemes in the 4 selected production in the North West Region.*
3. *The Grassfield Support Project for Rural Infrastructures and Participatory Development (GRASSFIELD II) now invites sealed bids from eligible bidders for the construction of water supply schemes in the 4 selected production basins in the North West Region.*

DEVELOPMENT OF 120ha OF LAND IN WIDIKUM PRODUCTION BASIN IN THE NORTH WEST REGION CONSISTING OF 2 OIL PALM PLANTATION BLOCKS, 3.4KM OF ACCESS ROAD WITHIN THE BLOCKS, 15.5KM TRACKS (5M WIDE) TO BE OPENED AND 3 BRIDGES TO BE CONSTRUCTED. DURATION 9 MONTHS

4. *National Competitive Bidding will be conducted in accordance with the Bank's **Rules and Procedures for Procurement of Goods and Works**. 5. *A complete set of Bidding Documents may be purchased by interested bidders upon submission of a written application to the above and upon payment of a non-refundable fee of **100,000FCFA** (one hundred thousand) payable to the cashier of Grassfield II against a receipt*
6. *The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of works.*

7. Bids must be delivered to the above office on or before 30 / 08 / 2018 at 11:00 a.m. prompt **and must be accompanied by a security in the amount in FCFA of: 6.5 million (six million five hundred thousands)**
8. Bids shall remain valid for 120 days after the deadline for bid submission prescribed above
9. Bids will be opened in the presence of bidders' representatives who choose to attend, on 30 / 08 / 2018 starting 12:00 noon in the Conference Hall of Grassfield II at the same address.
