1. Subject of the invitation to tender

Within the framework of the drilling of equipped boreholes with human activated pumps in some villages Mayo-danay Division, the Major of DATCHEKA Council, Contracting Authority, hereby launches an Open National Invitation to Tender in Emergency Procedure for the DATCHEKA COUNCIL.

2. Borehole of TAALA - FALE per2;
3. Borehole of KABI per3;

2. Nature of works

The works subject of this contract include:

- Etude hydrogéologique et implantation du forage ;
- Forage proprement dit ;
- Equipement du forage ;
- Développement ;
- Essai de pompage et de débit ;
- Equipement de surface ou superstructure ;
- Pose de pompe manuelle

3. Execution dateline

The maximum execution dateline provided by the Project Owner for the execution of the works subject of this tender shall be two (02) months.

4. Allotment

5. Estimated cost

The estimated cost of the operation following prior studies stands is eight millions (8 000 000) francs CFA.

6. Participation and origin

Participation in this invitation to tender is open to equal conditions to Cameroon-Low related firms and companies experienced in Rural engineering.

7. Financing

Works which form the subject of this invitation to tender shall be financed by the Public Investment Budget for the 2019 Financial Year.

8. Provisional bid bond

Each bidder must include in this administrative documents, a bid bond issued by a first rate-bank approved by the Ministry in charge of Finance featuring on the list in document 12 of the tender file of an amount of one hundred and seventy thousand (160 000) francs CFA and valid for thirty (30) days beyond the original date of the validity of the offers.

9. Consultation of tender file

The file may be consulted during working hours at the DATCHEKA council, as soon as this notice is published.

10. Acquisition of tender file

The file may be obtained from the DATCHEKA council, as soon as this notice is published against payment of a non-refundable sum of fourty thousand (40 000) francs CFA payable at the public treasury.

11. Subdivision of tender

Each offer drafted in English or French in seven (7) copies including the original and six (6) copies marked as such, should reach at the DATCHEKA council, , not later than 15 April/2019 at 02 p.m., local time and should carry the inscription:

12. Admissibility of offers

Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the fissuring service or an administrative authority (Senior Divisional Officer, Divisional Officer) in accordance with the special conditions of the invitation to tender. They must not be older than three preceding the original date of subdivision of bids (3) months or must not have been established after the signing of the tender notice.

Any incomplete offer in accordance with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

13. Opening of bids

The opening of all bids is done in a single phase.

The opening of the administrative documents, the technical and financial offers shall take place on 15 April/2019 at 03 o'clock by the Tenders Board attached to the DATCHEKA council.

Only bidders may attend or be duly represented by a person of their choice, (event in the event of a joint-venture) with sound knowledge of their files.

13. Evaluation criteria

14.1 Eliminary criteria

The eliminatory criteria set the minimum conditions to be fulfilled in order to execute works subject of the tender. They could be:

- Absence of the provisional bid bond,
- False declaration or falsified documents,
- Non-conformity of technical specifications (sub-detailed price, quantified unit price),
- Failure to score at least **twenty-two (22)** out of the **thirty-two (32)** essential criteria;
- Absence of a quantified unit price,
- Non-conformity of the model of provisional bid bond.

14.2. Essential criteria

- Presentation out of **3 criteria**;
- Contractor's references and pre-financing capacity out of **4 criteria**;
- Methodology out of **7 criteria**;
- Execution planning out of **3 criteria**;
- Supply planning out of **3 criteria**;
- Supervisory staff out of **9 criteria**;
- Site equipment to be mobilized out of **3 criteria**.

15. Award

The Mayor of DATCHEKA Council, the Contracting Authority, shall award the contract to the tenderer with the lowest and technically compliant bid deemed to be essentially in keeping with the tender file. For this invitation, two lots and more can be awarded to one applicant.

16. Validity of offers

Bidders will remain committed to their offers for a period of ninety (90) days with effect from the deadline set for the submission of tenders.
