Within the framework of the building works of two classrooms block in some government Primary schools of the Mayo-Danay Division, the Mayor of the DATCHEKA Council, Contracting Authority, hereby launches an Open National Invitation to Tender in Emergency Procedure for the Ministry of Basic Education.

2. Nature of Works

The works, object of this national invitation to tender comprise the following tasks inter alia:

12. Admissibility of offers.

Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the issuing service or an administrative authority (Senior Divisional Officer, Divisional Officer...) in accordance with the Special Conditions of the invitation to tender.

They must not be older than three preceding the original date of submission of bids (3) months or must not have been established after the signing of the tender notice.

Any incomplete offer in accordance with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank or a assurance company approved by the Ministry in charge of Finance.

13. Opening of bids

The bids shall be opened in single phase.

- a) Incomplete financial offer;
- b) Non-compliant documents;
- c) Omission of a quantified unit price in the financial offer;
- d) Absence of a sub-detailed price;
- e) Unrealistic and erroneous sub-detailed price
