The Government of Cameroon has received a loan and grant from the African Development Bank in various currencies to finance the cost of the Grassfield Support Project for Rural Infrastructures and Participatory Development (GRASSFIELD II). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for the Supply of 03 cassava processing units in Widikum production basin
3. The Grassfield Support Project for Rural Infrastructures and Participatory Development (GRASSFIELD II) now invites sealed bids from eligible bidders for the supply of the following goods (herein called "the Goods")
