The Government of Cameroon has received a loan and grant from the African Development Bank in various currencies to finance the cost of the Grassfield Support Project for Rural Infrastructures and Participatory Development (GRASSFIELD II). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for the construction of building coffee quality and pre-control services in NWCA.
3. The Grassfield Support Project for Rural Infrastructures and Participatory Development (GRASSFIELD II) now invites sealed bids from eligible bidders for the
