**BEARING THE CANCELLATION OF THE TENDERING PROCESS FOLLOWING  
INVITATION TO NATIONAL COMPETITIVE BIDDING TENDER No: 023/2021/NCB/STB  
/GP-IRDP OF 01/06/2021 FOR THE CONSTRUCTION/REHABILITATION OF WATER  
SUPPLY SCHEMES IN THE NORTHWEST REGION IN 6 LOTS**

**THE PROJECT COORDINATOR**

- Mindful of the constitution of the Republic of Cameroon;
- Mindful of law No. 2007/806 of 26/12/2007 bearing on the finance regime of Cameroon;
- Mindful of the Loan/Grant Agreement No. 2100150030193/2100155026167 dated 16/12/2014 between the African Development Bank and the Government of Cameroon for the financing of the Grassfield Support Project for Rural Infrastructures and Participatory Development Project (Grassfield II);
- Mindful of Decision No. 0908/MINADER/CAB of 12<sup>th</sup> September 2013 creating the Project Management Unit of Grassfield II;
- Mindful of Decision No. 0909/MINADER/CAB of 12<sup>th</sup> September 2013 appointing the Project Management Staff of Grassfield II and appointing Mr Muluh Gregory Nguh as Project Coordinator of Grassfield II;
- Considering the Project Appraisal Report of GP-IRDP recommending the reinforcement of the existing Project Management Unit of Grassfield II to manage the GP-IRDP
- Considering the Open national invitation of to tender No: 023/2021/NCB/STB/GP-IRDP OF 01/06/2021 for the construction/Rehabilitation of water supply schemes in the Northwest Region in 6 lots
- Considering the IsDB recommendation letter No. RHA/CAMEROON/GP-IRDP/PPR-10394/0111/2021 of 01/11/2021 declining the approval of the evaluation report and award recommendation of the Special Tender Board of Grassfield II.
- Considering the necessity of service;

**DECIDES as follows:**

Article 1: The tendering process following invitation to National Competitive Bidding No: 023/2021/NCB/STB/GP-IRDP OF 01/06/2021 for the construction/Rehabilitation of water supply schemes in the Northwest Region in 6 lots has been cancelled.

The Reasons for cancellation:

**The Islamic Development Bank declined approving the Bid Evaluation Report and award recommendations of the Special Tenders Board of GP-IRDP for non-compliance to the guidelines.**

Article 2: The Contract Award Expert of GP-DERUDEP II is charged with the responsibility of informing the concerned
