Within the framework of 2022 Investment Budget, the mayor of Bamenda III Council hereby launches an Open National Invitation to Tender for the Construction of a Fence at G.P.S Nibung Nkwen in Bamenda III Municipality in Mezam Division of the North West Region.

#### 2. Nature of work:

Work to be done consists of

- Preparatory works
- Earth works

- Painting

# 3. Execution deadline

The maximum deadline provided by the Contracting Authority for the execution of the works forming the subject of this invitation to tender **three (03) calendar months** 

#### 4. Estimated cost

The estimated cost after preliminary studies is 20, 000 000 (Twenty millions) CFA Francs.

## 5. Participation and origin

Participation to this invitation to tender is open to Cameroonian enterprises that are in compliance with the fiscal laws.

#### 6. Financing

Works which form the subject of this invitation to tender shall be financed by the 2022 Public Investment Budget of the **Ministry of Basic Education**.

#### 7. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in

document No. 12 of the Tender File, of an amount of **400,000** *CFA* (four Hundred thousand) *CFA* Francs, valid for thirty (30) days beyond the date of validity of bids. As per article 90 (9) of the Public Contract Code (Decree No. 2018/366 OF 20 June 2018), certified cheques or bank cheques are acceptable in the place of bid bond.

#### 12. Admissibility of bids

Under penalty of being rejected, only originals or true copies certified by the issuing service or administrative authorities (Senior Divisional Officer, Divisional Officers) must imperatively be produced in accordance with the Special Regulations of the invitation to tender.

They must obligatorily be not older than three (3) months preceding the date of **launching of** the tenders or may be established after the signature of the tender notice

Any bid not in compliance with the prescriptions of the Tender File shall be declared inadmissible. This refers especially to the absence of a bid bond issued by a first-rate bank approved by the Minister in charge of Finance.

#### 13. Opening of bids:

The bids shall be opened in a single phase. The opening of the administrative documents, the Technical and Financial offers will take place on the **25/02/2022 at 11AM** local time, in the conference hall of Bamenda III Council, by the Bamenda III Council Tenders Board. Only bidders may attend or be represented by duly mandated persons of their choice.

## 14. Evaluation criteria

The bids shall be evaluated according to the main criteria as follows:

# A. Eliminatory criteria

- 1. -Deadline for delivery higher than prescribed;
- 2. -False declaration or falsified documents;
- 3. insufficient bid bond; not corrected after 48hrs of opening time
- -A bid with the external envelope carrying a sign or mark leading to the identification of the bidder;
- 5. -Incomplete financial file;
- 6. Omission of a unit price in the financial bid;
- 7. -Change of quantity or unit;
- 8. -Non respect of (75%) of essential criteria;

During the opening session of the bids if a document of the administrative bid is absent or noncompliant, the bidder will be given forty-eight (48) hours to produce or replace the said document else it will be eliminated during the evaluation of the bids. No such document will be accepted after this deadline.

B. Essential criteria

General presentation of the tender files;

2- Financial capacity;

3- References of the company in similar achievements

4- Quality of the personnel;

5- Technical organization of the works;

6- Safety measures on the site;

7- Logistics;

8- Attestation and report of site visit;

9- Special Technical Clauses initialed in all the pages;

10-Special Administrative Clauses completed and initialed in all the pages.

These essential criteria are subject to lower limits, the details of which are spelled out in the Special Regulations of the invitation to tender

# 15. Award

This evaluation will be done in a purely a purely binary method with a positive (yes) or negative (no) with an acceptable minimum of 75% of the essential criteria taken into account.

The contract will be awarded to the bidder who would have proposed the offer with the lowest reasonable amount, in conformity with the regulations of the Tender Documents and having satisfied to 100% of the eliminatory criteria and at least 75% of the essential criteria. Pursuant to justification by bidder, unconvincing abnormally low costing will not be accepted spelled out in the Special Regulations of the invitation to tender of this consultation.

16. Validity of bids

Bidders will remain committed to their offers for sixty (60) days from the deadline set for the submission of tenders.


