Notice of Call of Open National Offers In Emergency Procedure

For the construction of one block of three (03) classrooms + two offices at the BIOU high school

1. Subject of the Call for Offers

As part of the execution of the title, the Prefect of the Department of MAYO LOUTI, Delegated Master of Work and Contracting Authority launches an Open National Offer Appeal in emergency procedure on behalf of the recipient administration.

2. Consistency of work

The work includes:

- ✓ Preparatory work;
- ✓ Terracing;
- ✓ Foundation;
- ✓ Masonry - elevation;
- ✓ Frame and cover;
- ✓ Metal carpentry;
- ✓ Electricity;
- ✓ Painting;
- ✓ VRD.

3. Deadlines

The deadline provided by the Master of Work for the completion of the work subject to this tender is a maximum of **four (04) months** from the date of notification of the order of service to start the work.

4. Allotment

The work is in a single batch.

5. Projected cost

The projected cost of the operation following the pre-studies is **35,000,000 CFA francs**.

6. Participation and origin

Participation in this invitation to tender is open on equal terms to Cameroonian companies established in Cameroon with experience in the field.

The participation of companies in the form of a group or subcontracting is allowed in accordance with the regulations in force.

7. Funding

The works that are the subject of this call for tenders are financed by the Public Investment Budget (BIP) of the Republic of Cameroon in fiscal year 2022 on the budget allocation line **56-25-105-0156-15082-2222**

8. Provisional bonding

Each bidder must attach to its administrative documents a bid guarantee issued by a first-rate bank approved by the Ministry of Finance and listed in Exhibit 12 of the DAO, amounting to **seven hundred thousand (700,000) CFA francs** and valid for ninety (90) days beyond the original date of validity of the bids.

9. Consultation of the Call of Offers File

The file can be consulted during working hours at the GUIDER Prefecture, Private Secretariat, and Telephone: 222 39 51 14 / 222 39 51 01 as soon as this notice is published.

10. Acquisition of the Call of Offers File

The file can be obtained from the Special Secretariat of the Prefecture of GUIDER, Telephone: 222 39 51 14 / 222 39 51 01 as soon as this notice is published by print (*JDM, Cameroon-tribune*) and by way of display on the premises of said structure, in exchange for payment of a non-refundable sum of **fifty thousand (50,000) CFA francs**, payable to the **public treasury**.

11. Offer delivery

Each offer written in French or English in seven (07) copies, including one (01) original and six (06) copies marked as such, must be sent to the Prefecture of GUIDER, Secretariat Individual, no later than **18/03/2022 at 10 a.m.** and must bear the mention:

12. Offer eligibility

Under penalty of rejection, the documents in the required administrative file must be produced in originals or certified copies by the issuing service or an administrative authority (Prefect, Sub-prefect, etc.), in accordance with the provisions of the Supplementary Regulations for the Call for Offers

They must be less than three (03) months before the original bid date or have been established after the date of the signing of the Notice of Call for Offers.

Any incomplete offer in accordance with the prescriptions of the Tender File will be declared inadmissible. In particular the absence of the bid bond issued by a first class bank approved by the Ministry of Finance.

13. Opening the folds

The opening of the folds will be carried out in one (01) only time in the meeting room of the PREFECTURE of GUIDER. The opening of administrative, technical and financial offers will take place **18/03/2022 at 11 a.m.** local time by the Departmental Public Procurement **Commission**.

Only bidders can attend or be represented by a person of their choice.

14. Evaluation criteria

1. Elimination criteria

1.1 Administrative Offer

- Absence of submission caution,
- False statement or forged part.

1.2 Technical Offer

- False statement or falsified part,
- Absence of the declaration of honour by which the bidder attests that not only has it not abandoned the market in the last three years, but also, it is not on the list of failing companies annually established by the Minister of Public Markets;
- No own possession or for rent of a pick-up or van type link vehicle (supporting parts: certified copy of the grey card or clearance certificate);
- Absence of the site visit certificate signed on the honour by the bidder;
- Lack of work schedule;
- Technical rating less than 12 yes out of 16 yes.

1.3 Financial Offer

- Incomplete financial offer;
- Non-compliance with the bid model;
- Non-compliance with the quantities of the quantitative quotation tasks derived from the DAO;
- Lack of a quantified unit price.

2. Essential criteria

The criteria for the qualification of candidates will be as an indication on:

- Financial situation
- Experience;
- Personal;
- Materials;
- Work-execution methodology and planning
- General presentation of offers

15. Attribution

The Delegated Contracting Authority will award the contract to the bidder whose bid has been found to be essentially in line with the Call for Offers file. The latter will have to have the technical and financial capacity to execute the Market satisfactorily and the offer was assessed as the least telling, including the proposed discounts if necessary.

16. Maximum number of lots

Not applicable.

17. Duration of offers

Bidders remain committed to their bid for 90 days from the deadline for submitting bids.

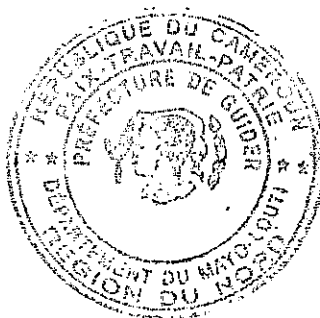
