9. ADMISSIBILITY OF OFFERS:

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender, within the last three months, otherwise they shall not be accepted.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible.

10. BID BOND.

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance in conformity with COBAC conditions and whose list is found in document N° 11 of the tender file, of an amount of **six hundred thousand FCA (600,000Frs) CFA** valid for thirty (30) days beyond the date of validity of offers.

On pain of being rejected, only originals or true copies certified by the issuing service or administrative authorities (Senior Divisional Officer, Divisional Officers) must imperatively be produced in accordance with the Special Regulations of the invitation to tender.

They must obligatorily be not older than three (3) months preceding the date of submission of offers or may be established after the signature of the tender notice

Any offer not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. 13. MAIN EVALUATION CRITERIA

There are two types of evaluation criteria: eliminatory criteria and essential criteria. The aim of this criteria is to identify and reject incomplete bids or bids not in conformity with the essential conditions laid down in the Tender File.

A/Eliminatory Criteria.

A bid shall be rejected if:

- The technical score is less than the minimum required;
- It has any fake or forged document;
- It lacks any quantified unit price;
- It carries any false information.
- It does not respect the model documents

NB: when an administrative document is missing or found to be non-compliant during the bid opening session, the bidder shall have 48hrs (forty eight hours) to produce or replace the document concerned.

NB: Bidders with incomplete or abandoned projects may be disqualified

B/Essential Criteria.

Essential criteria are primordial in the judgment of the technical and financial capacity of candidates to execute the works forming the subject of the invitation to tender. The criteria relating to the qualification of candidates are based on the following;

- Experience of supervisory staff,
- Logistics (equipment),

- Attestation of site visit signed by the bidder,
- Report of site visit signed by the bidder,
- The Special Administrative clauses (SAC), each page should be initialled and the last page signed and stamped.
- The Special Technical Clauses (STC). Each page should be initialled and the last page signed and stamped.
- Pre-financing capacity not less than 50% of the amount required in the offer.

The essential criteria are subjected to minima whose detail is given in the Special Regulation of the Invitation to tender (RPAO).

C/Main qualification Criteria.

Non-respect of two (02) of the above criteria shall entail rejection of the bid.

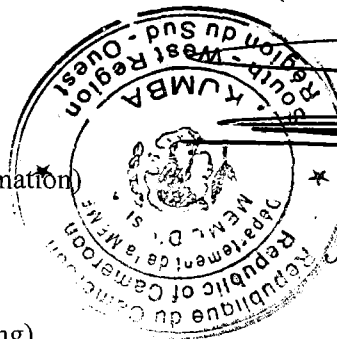
