1. Purpose of the invitation to Tender

The President of the West Regional Council, Contracting Authority, is launching a National Invitation to Tender in emergency procedure for:—the building of a block of two (02) classroom in the Government Bilingual High school of Badounga (batch 1), the building of a block of two (02) classroom in the CETIC of banyabo at Bassamba (batch 2) and the building of a block of two (02) classroom in the Bilingual CES of Tonga Nyetkoh (batch 3) in the Nde Division.

3. Execution deadline

The duration provided by the Client for the fulfillment of services subject of this tender is 03 (three) months for the barches 1 and 2, and 04 (four) for the batch 3; from the date of notification of the service start-up.

The estimated cost of the operation at the end of the preliminary studies is:

5. Participation and origin

Participation in this invitation to tender is open on equal terms to Cameroon-based companies with adequate expertise in the BTP sector.

The participation of companies in group is allowed provided that the lead partner is designated and that the specific attributions of each member of the grouping are clearly stated in the grouping agreement.

6. Financing

The works covered by this invitation to tender are financed by the Budget of the West Regional Council of the West Regional Council, for the 2022 Financial Year.

7. Provisional Bond

Each bidder shall attach in his administrative documents, a bid bond issued by a first institution approved by the Ministry in charge of Finance featuring in the tender file, an amount of 381 600 (three hundred and eighty one thousand six hundred) FCFA Francs for the batches 1 and 2 and 763 200 (Seven hundred and sixty-three thousand two hundred) FCFA Francs for the batch 3.

This provisional bid bond shall be delivered 30 days valid for one hundred and twenty (120) days beyond the original date of the validity of the offers.

8 Consultation of the tender file

The tender file can be consulted during working hours at the headquarters of the West Regional Council in Bafoussam as soon as this notice is published

9. Acquisition of the tender file

The file can be collected during working hours as soon as this notice is published upon payment of a non-refundable sum of 56 000 (fifty-six thousand) CFA francs, at the Treasure of the West Regional Council.

10 Submission of bids

Each bid drafted in English or French in seven (07) copies, one (01) original and six (06) copies labeled as such, must reach the Secretariat of the President of the West Regional Council at Bafoussam B.P: 1112; no later than the 02 September 2022 at 10 Am, local time, and shall bear the following:

11. Admissibility of bids

Under penalty of rejection, the administrative documents required, shall be produces in originals of true copies certified by the issuing service or an administrative authority (Sub-Divisional Officer, Divisional Officer ...) in accordance with the with the provisions of the Special Rules of the invitation to Tenders.

They must be dated within three (03) months prior the original bid submission date or after the date of signature of the tender notice.

Any incomplete offer in accordance with the requirements of the bidding documents shall be declared inadmissible.

NIII Any bid received after the times and dates prescribed in the tender file will be rejected outright.

12. Opening of bids

The bids shall be opened once, on the 02 September at 11 AM. The evaluation of the administrative, technical and financial bid will be done by the Internal Tender's Board at the headquarters of the West Regional Council at SOCADA.

13. Evaluation criteria

1. Eliminatory criteria

13.1Critères éliminatoires

- i) Absence of Administrative Document or not in conformity with the bid opening and not corrected within 48 hours:
- (ii) false statement scanned or presentation in the offer of falsified documents;
- (iii) Non-compliance with the models and requirements of the SOW;
- (iv) Omission of a quantified unit price in the Financial Offer;
- v) Pailure to meet at least 70% of the essential criteria;
- vi) Absence of the bid bond;
- vii) Absence of a declaration on honor that no project has been abandoned in the last three years;
 - viii) Have a project for the year 2021 still in progress due to the company.
 - Absence of financial capacity in the amount at least equal to one the third of the estimated amount of the lot applied.



13.2 Essential criteria

Bids shall be evaluated according to the following criteria:

- i) General presentation of the bid (03 criteria);
- ii) Bidder's references (05 criteria);
- iii) Qualification and experience of the supervisory staff (06 criteria);
- iv) Availability of essential equipment and materials (06 criteria);
- v) Methodology (organization, planning, site visit...), adopted (05 criteria);
- vi) Financial offer (02 criteria);

Any bidder must satisfy at least 23 yes/32 to be qualified

14. Contract award

The contract is awarded to the bidder having presented offers in conformity, administratively, technically qualified and financially, and evaluated as the lowest best bid.

NB: A bidder cannot be awarded more than two batches.

15. Validity of tenders

Bidders are bound by their offers for a period of ninety (90) days, from the deadline set for the submission of tenders.
