7- Admissibility of offers

Each bidder must include in his administrative documents, a bid bond issued by a first rate-bank approved by the Ministry in charge of finance of an amount of 2 % of the predicted amount, valid for one hundred and twenty (120) days from the date of bid-opening, that is 440 000 (Four hundred forty thousand) CFA Francs.

Under pain of being rejected, only originals or true copies certified by the issuing service or administrative authorities (senior Divisional Officers, Divisional officers...) of the administrative documents required, including the bid bond, must imperatively be produced in accordance with the Special Conditions of the invitation to tender.
