1. The Government of the Republic of Cameroon has obtained from the World Bank, the loan agreement No. 6643-CM for the financing of the Lake Chad Region Recovery and Development Project (PROLAC). It intends to use part of this loan to make the expected payments for the "subscription of a health insurance policy in favor of the staff of the Implementation Unit of the Lake Chad Region Recovery and Development Project and their families".
2. Collection of the Request for Quotations: the PROLAC National Coordinator invites interested Service Providers who meet the required conditions to withdraw the request for quotations. The consultation file can be withdrawn free of charge against discharge from **Monday to Friday from 8 a.m. to 4 p.m. local time** at the Project Implementation Unit located in the residential area opposite the KOUSSERI Central Police Station.
3. Submission of tenders: the quotations shall be submitted in seven (07) copies (of which one (01) original and six (06) copies including the digital copy) to the address below, no later than **06 SEPT 2022** at 13:00 hours, local time with the mention: "**Request for Quotations No 0171 /RFQ/MINEPRD/PROLAC/PIU/STB 2022 for the subscription of a health insurance policy in favor of the staff of the Implementation Unit of the Lake Chad Region Recovery and Development Project and their families**, to be opened only during the bid opening session".
4. Opening of bids: The opening of the quotations will take place at the UMOP headquarters, on **06 SEPT 2022** at 14:00 local time, in the presence of the bidders or their representatives, by the Special Procurement Commission (CSPM) at PROLAC.
5. Qualification criteria:
 - ❖ **Eliminatory criteria**
The eliminatory criteria of this tender are the following:
 - False declarations substituted or forged administrative documents;
 - Absence of the approval;
Tenders will not be evaluated:
 - ✓ whose bidders are under Provisional Administration or CIMA supervision
 - ✓ whose bidders do not have MINFI approval and CIMA membership
 - Technical score less than 70%.

- Did not take into account the full third-party payment formula
- No provision of biometric cards

❖ **Essential criteria**

- General presentation of bid
- Bidder's References in similar risks during the last three years (attach the first and the last pages of the contract)
- Detailed description of guarantees offered
- Representativeness over the territory
- Coverage of regulated commitments
- Coverage of the solvency margin

6. Validity Period of the offers: the quotations will remain valid for **ninety (90) days** from the date of the opening of the bids.
