2. Consistance des travaux

3. Délai d'exécution

2. Consistency of the work

The works include for each batch:

3. Exécution deadline

Lead time provided by the representatives of the employer for the realization of the work of the present call for tenders is **three (03) months** maximum.

4. Allotment

The works are not divided in lots

5. Estimated cost

The estimated cost of the operation at the end of preliminary studies is to: **8 900 000 CFA francs**

6. Participation and origin

The participation to the present tender is open to all Enterprises under the business law of Cameroon.

7. Funding

The works objet of present call offers are funded by the MINSANTE Budget of the Exercice 2023 and following.

8. Temporary bonding

Each bidder shall attach to its administrative documents, a bid bond established by a first-class Bank approved by the Ministry of finance and the list of which appears in Exhibit 12 of the DAO, **in accordance with the table amount below** and valid for thirty (30) days beyond the original date of validity of offers: **178 000 CFA francs**

Any incomplete offer in accordance with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of abidbond issued by a first-rate bank approved by the Ministry in charge of Finance.

13. The bid opening

The administrative, technical and financial offers will be opened **08/03/2023 à 11 hours**, specific hours, local time, by Divisional Tenders Board Commission Audiences of the Figuil Council. Only bidders can attend this opening meeting or be represented by a duly authorized person of their choice.

14. Evaluation criteria

1.Play off criteria

1.1 Administrative offer

- ▯ Absence of a required administrative room after 48 Hours time limit
- ▯ False statement or falsified material.
- Absence of a submission caution.

1.2 technical offer

- False statement or falsified, room
- Absence of the affidavit by which the Bidder certifies that not only he has not abandoned the contracts during last three years, but also, it is not on the list of failing firms annually established by the Minister of public contracts
- Technical note less than 14 Yes on 20 criteria.

1.3 Financial offer

- Incomplete financial offer;
- Non-compliance of the submission to the DAO model;
- Absence of a quantified unit price.

2. Essential criteria

Criteria for the qualification of candidates will be for guidance on:

- Financial situation;
- Experience;
- Personnel;
- Materials;
- The work methodology and planning
- Overview of offers

15. Award

The Mayor of Figuil Council will award the contract to the bidder whose offer has been recognized in substantial compliance to the tender file and which has the technical and financial capacity required performing the contract satisfactorily and whose supply has been evaluated the less so-called including applicable proposed discounts

16. Running time offers

Bidders remain committed by their offer for 90 days from the date of deadline for the submission of the offers.


