#### 10. Submission of Bids

# 11. Bid Bond:

Each bidder must include in his administrative documents a bid bond issued by a first-rate banking/insurance establishment approved by the Ministry in charge of finance and whose list is found in document N° 12 of the Tender File and valid for thirty (30) days beyond the date of validity of bids amounting to FCFA 2,000,000 (two million francs).

#### 12. Admissibility of Bids

Subject to being rejected, documents in the administrative file must include only originals or true copies certified by the issuing service or competent administrative authorities in accordance with the Special Regulations of the invitation to tender. These documents must be less than three (3) months old or established after the signing of the tender notice.

Any bid not in conformity with the prescriptions of the Tender File shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Minister in charge of Finance or the non-respect of the model documents in the tender file shall lead to a pure and simple rejection of the bid.

13. Opening of Bids

The bids shall be opened in a single phase on 10/03/2023 at 11a.m. local time in the Conference Hall, at the Menji council office by the Menji council internal tenders board. Only bidders may attend or be represented by a duly mandated person.
