7. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of 500 000 CFAF and valid for thirty (30) days beyond the date of validity of bids

11. Admissibility of bids

Under pain of being rejected, only originals or certified true copies from the issuing service or administrative authorities (Senior Divisional Officers, Divisional Officers, etc.) of the documents required must imperatively be produced in accordance with the special

conditions of the Invitation to tender. They must not be older than three (03) months.

Any bid not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge of Finance or the non-respect of the models of the Tender File documents shall lead to outright rejection of the bid without appeal.

12. Opening of bids:

The bids shall be opened in a single (01) phase on the 1.1.2.2023 at 11am local time by the Tenders Board of the Contracting Authority in the Conference Hall of the Mayor of Dikome Balue Council. Only bidders may attend or their duly accredited representatives with Power of Attorney.
