Works which form the subject of this invitation to tender shall be financed by the Budget of the Maroua City Council financial; Budget Heads No.

6. Provisional bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first rate-bank approved by the Ministry in charge of Finance featuring on the listing document 12 of the tender file of an amount of **540 000 F CFA for the share** valid for thirty (30) days beyond the original date of the validity of the offers.

10. Admissibility of offers.
