I - Subject

Within the framework of the 2023 National Investment Budget, the mayor of Maroua 2 council (Contracting Authority) hereby launches for MAROUA II MAYOR AN OPEN NATIONAL INVITATION TO TENDER FOLLOWING EMERGENCY PROCEDURE, FOR THE REHABILITATION OF THE FOUNANGUE HOSPITAL MAROA II, in MAROUA II Council, DIAMARE DIVISION, FAR -NORTH REGION.

II- Nature of services

The works, which form the subject of this open national invitation to tender, shall consist in the construction of two classrooms in Government Primary School, in MAROUA II Council.

The services of this contract include:

- Preliminary work ;
- Masonry from the foundation and walls;
- Roof and ceiling works ;
- Metal joinery;
- Electrical works;
- Painting ;
- Road and utilities.

III - Participation and origin

Participation to this invitation to tender is open to Cameroonian enterprises that are in compliance with the fiscal laws and having a good experience in the domain concerned. Each bidder must give true information that will lead to choose the one who will carry out the contract well.

IV - Financing

The works which form the subject of this invitation to tender are financed by the National Investment Budget of the Ministry of Primary Education for the 2023 financial year, for the amount of fifty million (50 000 000) francs CFA

V - Consultation of tender documents

Upon the publication of this notice, tender documents can be consulted during working days and hours at the **Launching Contracts Support Unit (LCSU) of the SIGAMP of maroua 2 council**

VI - Acquisition of tender documents

A complete set of bidding documents must be purchased at the **particular secretary of the mayor of maroua 2 council**, by interested bidders as soon as this notice is published upon presentation of a receipt of payment of a non-refundable fee of **80.000 (eighty thousands) francs CFA** at the Public Treasury.

VII- Presentation of bids

The bids must be sealed in three envelops.

- The first containing administrative file;
- The second dealing with technical file;
- The third containing financial documents.

All the three envelops must be wrapped in a single envelop unto which the reference of the invitation to tender must be written.

Furthermore all the different documents have to be separated with a colored paper in order to distinguish them one from another.

VIII - Submission of bids

Seven (07) copies of sealed complete bids (**one certified copy of originals and six photocopies**) drafted either in English or French must be submitted at the **Launching Contracts Support Unit of particular secretary of the mayor of maroua 2 council** latest **1 p.m. local time on 03/04/2023** with the reference:

IX - Admissibility of bids

Each bidder must include in his /her administrative file a **provisional guarantee of the tune for the amount of ONE MILLION (1 000 000) Francs CFA** issued by a first-rate bank or Financial Institute registered at the Ministry of Finance.

For fear of rejection, the required administrative documents must be produced in original or certified true copies by the services who issued them bound, dating any less than three months.

Any bid not in conformity with the specifications of this tender file shall be rejected. Notably, the absence of the provisional guarantee issued by a first-rate bank or Financial Institute approved by the Ministry of Finance or the noncompliance of the model documents of the tender file shall lead to outright rejection of the bid without any possible appeal.

X - Opening of bids

The opening of bids will be in one phase in the presence of bidders or their duly mandated representative who choose to attend on—**03/04/2023** -at **2p.m.** local time at the **maroua 2 council**.

XI- Deadline of submitting the bids

The deadline set for submitting bids by interested bidders is **twenty one (21) days** as soon as this notice is published.

XII - Execution deadline

The maximum deadline provided for by the Contracting Authority is **three (03) months** with effect from notification of the contract.

XIII - Main evaluation criteria

A)- Eliminary criteria

- Absence of any of the administrative file;
- Fake document in the administrative file;
- False declaration in the administrative file;

B)- Main technical qualification criteria

The criteria relating to the qualification of bidders are the following:

- Financial capacity (access to credit or any other financial resources, turnover, Provisional guarantee)..... yes/no;
- References of the enterprise (generally or previous experience on similar projects complexity cost.....) executed within the last (03) three years Yes/no;
- Experience and qualification of the supervisory staff yes/no;
- Methodology and job planningyes/no;
- The availability of materials and other essentials equipment's.....yes/no;
- Running Capital (transactions for 2021 year) and expectation for 2022.....yes/no;
- Technical report of the site visit..... yes/no.

These criteria are further divided into **49** sub criteria in such a case that only bidders who will have obtained **34 YES** over **49** in technical score shall be admitted to the financial analysis.

XIV - Time frame for the validity of bids

The bidders remain legally engaged by virtue of their tender for a period of **ninety (90)** days from the deadline set for the submission of their bids.

XV - Award of tender

The Divisional Delegate of the Ministry of Publics Contracts (Contracting Authority) shall award the tender to the lowest bidder, whose technical and financial file conform with the tender documents in accordance with the provisions of **article 6** of page **30** through **34** of the regulations governing the tender showing the technical evaluation of bids.

XVI - Further information

Complementary technical information related to the tender file can be obtained during working days and hours at the **particular secretary of the mayor of maroua 2 council**, as soon as this notice is published.
