Subject of the invitation to tender:

Within the framework for the rehabilitation of Bertoua CAM, the Governor of the East region, Contracting Authority hereby launches an open national invitation to tender for the Ministry of Social Affairs.

1. Nature of works:

These works comprise the following operations whose list is not exhaustive:

- Preliminary works;
- Frame work- coverage and ceiling;
- Wood carpentry ;
- Metal carpentry ;
- Masonry ;
- Electricity and security ;
- Sanitary Plumbing and Tiling ;
- Painting of the building ;

2. Participation and origin:

The participation to the present tender is open to all Enterprises under the business law of Cameroon and involved in the building and construction and public works sectors.

3. Financing:

Works of this invitation to tender shall be financed by the PUBLIC INVESTMENT BUDGET (PIB) of the Republic of Cameroon, Exercise 2023.

The estimated cost of the operation from the previous is of: **25 500 000 FCFA**

4. Execution deadline:

The maximum execution deadline provided by execution of the works subject of this tender shall be to **Three (03) months**.

5. Administration in whose name the contract will be concluded:

At the end of the examination of the bids of the tenderers and the choice of the successful tenderer by the contracting authority, the contract will be concluded between the latter and the successful tenderer.

6. Consultation of tender file

The file may be consulted during working hours at the East Governor's office (Economic, Social and Cultural Affairs Division) as soon as this notice is published.

7. Acquisition of tender file:

The file may be obtained from commission support unit at the East Governor's office from publication of the present tender by press voice and notice voice in the offices of the East Governor's office as soon as this notice is published against payment of a non-refundable sum of twenty thousand (20 000) francs CFA payable at the public treasure.

8. Provisional bid bond:

Each bidder must include in his administrative documents, a bid bond issued by a first rate-bank approved by the Ministry in charge of Finance featuring on the list in document 12 of the tender file of an amount of **Five hundred and ten thousand (510 000) FCFA** and valid for thirty (30) days beyond the original date of the validity of the offers.

9. Submission of bids:

Each bid drafted in English or French in seven (7) copies including the original and six (6) copies marked as such, should reach at the East Governor's office not later than 12 AVR 2023 at 10 AM o'clock and should carry the inscription:

10. Admissibility of bids:

Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the issuing service or an administrative authority (Senior Divisional Officer, Divisional Officer...) in accordance with the Special Conditions of the invitation to tender.

They must not be older than three preceding the original date of submission of bids (3) months or must not have been established after the signing of the tender notice.

Any incomplete offer in accordance with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

11. Opening of bids:

The bids shall be opened in single phase.

The opening of the administrative documents, technical and financial offers shall take place on 12 AVR 2023 at 11 AM o'clock by the Tenders Board attached to the Contracting Authority in the east regional Delegation of Public Contract conference hall.

Only bidders may attend or be duly represented by a person of their choice.

12. Evaluation criteria:

Criteria for elimination or qualification of offers are as follows:

1. Eliminary criteria:

- ✓ Absence of the submissiveness guaranty,
- ✓ Distort declaration or piece falsified,
- ✓ Incomplete file or improper document parts 48 hours after the opening of offer (under reserve of article 92(9) of N°2018/366 of 20 june 2018 decret of public contracts);
- ✓ Technical note lower to 70%.
- ✓ Absence of an unit price quantified;
- ✓ Absence of under detail unitary price;
- ✓ Modification of denomination or quantity of estimated cost in the tender file;
- ✓ Incomplete financial offer.

13. Validity of offers:

Bidders will remain committed to their offers for 90 days from the deadline set for the submission of tenders.

14. Award:

The Contracting authority will assign the market to the tenderer whose offer has been recognized compliant for the main thing to the File of offer call and that arranges some requisite technical and financial capacities to execute the Market in a satisfactory way and whose offer has been valued least saying while including the proposed discounts if the case arises
