8. SUBMISSION OF BIDS:

Each bid drafted in English or French in six (06) copies including the original and five (05) copies marked as such, should reach the Private Secretariat of the Mayor of Idabato Council, against a receipt not later than 15/04/23 at 12 noon local time and the outer envelope labeled:

8. ADMISSIBILITY OF OFFERS:

Each bidder must include in his /her administrative documents a bid bond issued by a first rate bank approved by the ministry in charge of finance and recognized by COBAC. (Commission Bancaire pour l' Afrique Centrale) featuring on the list in Document 12 of the tender file of an amount of **one Million (1,000,000)** CFAF with a validity period of ninety (90) days from the date the bid are opened.

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation of Tender, within the last three months, otherwise they shall not be accepted.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first rate bank approved by the Ministry in charge of finance or its non- compliance with the model documents of then tender file shall lead to outright rejection of the bid without any possibility of appeal.

9. OPENING OF BIDS:

The bid shall be opened in a single (01) phase. The opening of the administrative/ technical files shall take place on 15/4/2023 at 1:00 pm local time by the tender Board of the contracting Authority in the Idabato Council Conference Hall, in the presence of the bidders or duly authorized representatives having full knowledge of the file (power of attorney). Only financial bids of bidders who have scored at leas 70% in the first phase shall be opened at a later date

10. DURATION OF EXECUTION:

The maximum period provided for the execution of the works is fixed at three (03) months.
