9. ADMISSIBILITY OF OFFERS:

 - 4. Change of quantity or unit of the estimate in the financial bid;
 - 5. Deadline for delivery higher than prescribed;
 - 6. Technical offer not in compliance with the general characteristics as in the technical specification;
 - 7. Non respect of 75% of essential criteria;

NB: During the opening session of the bids if a document of the administrative bid is absent or noncompliant, the bidder will be given forty eight (48) hours to produce or replace said document or be eliminated. No such document will be accepted after this deadline.

ii. . ESSENTIAL CRITERIA
