

TENDER NOTICE

OPEN NATIONAL INVITATION TO TENDER N° 001/ONIT/SWR/SWRA/ITB/BUEA/2023 OF 24/03/2023 FOR THE CONSTRUCTION OF THREE ELECTRIC-POWERED BOREHOLES WITH OVERHEAD TANKS IN BONAKANDA, MOWOTE AND MBONJO FAKO DIVISION - SW REGION.

1. PURPOSE

Within the framework of the Execution of the 2023 Investment Budget of the South West Regional Assembly, the President of the South West Regional Executive Council launches an Open National Invitation to tender for the Construction of Three Electric-Powered Boreholes with Overhead Tanks in Bonakanda, Mowote and Mbonjo, Fako Division - South West Region.

2. NATURE OF WORKS

The works that are subject of the present tender consist of:

- Preliminary works;
- Drilling works;
- Design-Cleaning and Development-Pumping test;
- Superstructure and of electric pump installation;
- Maintenance System
- Supply and installation a generator and house (Per lot)
- Installation of 2 stand taps

3. EXECUTION DEADLINE

The maximum execution deadline of the work shall be 03 (Three) months from the date of notification of Service Order for the commencement of works.

12. ADMISSIBILITY OF BIDS

Under penalty of being rejected, only originals or true copies certified by the issuing service administrative authorities must imperatively be produced in accordance with the Regulations of the invitation to tender. They must not be older than three (3) months before the latest date set for the opening of bids.

Any bid which is not in compliance with the prescriptions of the Tender File shall be declared inadmissible. This refers especially to the absence of a bid bond

13. OPENING OF BIDS

The offers shall be opened in a single phase. The administrative, technical and financial bids shall be opened in the Conference Hall on 24/04/2023 at 11.00 a.m., local time by the West Regional Assembly Internal Tender's Board in the presence of the bidders or their authorized representatives having full knowledge of the file (power of attorney).

14. EVALUATION OF BIDS

The evaluation of bids shall be carried out in three stages:

- 1st Stage : verification of the presence and conformity of each administrative document ;
- 2nd Stage : Evaluation of the technical bids ;
- 3rd Stage: Analyses of the financial bids.

The criteria of evaluation shall be as follows:

14.1 Eliminary Criteria

- Absence of bid bond;
- False declaration or falsified documents;
- Omission of a quantified task on the bill of quantities and cost estimates;
- Enterprise with an abandoned project in the Region;
- Non satisfaction of at least 70% of the main qualification criteria.

14.2 Essential Criteria

- General Presentation, compliance with the model bid.
- Methodological approach and relevance of proposed solutions;
- References of the bidder (experience of at least three (03) years in similar works) - (attach proof)
- Availability of material and essential equipment
- Experience of key supervisory staff
- Financial capacity FCFA 10,000,000 (Ten Million Francs) for lot 1 and 20 million for lot 2 ;
- Turnover, FCFA 12 million for lot 1 and 25 million for lot 2.

15. Award:

The jobbing order shall be awarded to the bidder whose bid is in conformity with the dispositions of the tender file and on the basis of the lowest bid and technically qualified, in accordance with Article 99(a) of the Public Contracts Code. That is, it shall be awarded to the bidder with a satisfactory technical score and the lowest financial offer.

16. Maximum Number of Lots

A bidder may bid for, and be awarded more than one Lot.

17. Validity of bids

Bidders will remain committed to their bids for 90 days from the deadline set for the submission of bids.
