1. Purpose of the call for tenders

As part of the execution of the 2023 public investment budget of the ministry of agriculture and rural development, the Mayor of the Commune of Datcheka, Contracting Authority launches on behalf of the Council of Datcheka, Project Owner, a Call Open National Tender for the rehabilitation works of the EFLC-GANGALANG-CSI CROSSROADS OF GANGALANG-EP KANKARWA (7,100 KM) AND SOUKOUKAYA ROAD (100 M), in the Datcheka Council, Department of Mayo DANAY, Far North Region.

2. Nature of works

The works include:

- Installations and preparatory work;
- Earthwork and pavement;
- Sanitation and protection works;

3. Execution deadline

The maximum period provided by the Client for the completion of the works, subject of this call for tenders is **three (03) months**.

4. Allotment

Not applicable.

5. Estimated cost

The estimated cost of the operation at the end of the preliminary studies is **twenty seven million (27,000,000) FCFA**.

6. Participation and origin

Participation in this invitation to tender is open on equal terms to all Small and Medium-sized Enterprises under Cameroon law.

7. Financing

The works subjects of this invitation to tender are financed by the Public Investment Budget of the ministry public work 2023 on budget lines of account:

8. Provisional bid bond

Each bidder must attach to his administrative documents, a bid bond established by a first-rate bank or any other structure approved by the Ministry of Finance and whose list appears in document 12 of the DAO, in the amount of **540,000 (five hundred forty thousand) CFA francs**, valid for thirty (30) days beyond the original date of validity of the offers.

9. Consultation of the bidding documents

The file can be consulted on working days and hours at the Municipality of DATCHEKA, with the Procurement Department as soon as this Notice is published.

10. Acquisition of the file

The file can be obtained from the Municipality of DATCHEKA as soon as this notice is published, upon presentation of a receipt for payment of a non-refundable sum of **35,000 (thirty five thousand) CFA francs**, payable to the Municipal Revenue of Datcheka.

11. Delivery of offers

Each offer written in French or in English in seven (07) copies including one (01) original and six (06) copies marked as such, must be submitted to the Municipality of Datcheka, no later than 16/05 /2023 at **1 p.m. H 00** and must bear the mention.

12. Admissibility of the offers.

On pain of rejection, the required administrative documents must be produced in original or certified true copies by the issuing service or an administrative authority (Prefect, Sub-Prefect, etc.), in accordance with the stipulations of the Supplementary Regulations of the Appeal offers. They must be less than three (03) months preceding the original date of submission of tenders or have been established after the date of signature of the Tender Notice. Any incomplete tender in accordance with the requirements of the Bidding Documents will be declared inadmissible, in particular the absence of the bid bond issued by a first-rate bank approved by the Ministry of Finance.

13. Opening of the file

The opening of the folds will be done in one time. The opening of administrative documents, technical and financial offers will take place on 16/05 /2023 at **2:00 p.m.** by the Internal Tenders Commission located in the Municipality of Datcheka. Only bidders may attend this opening session or be represented by a duly mandated person of their choice.

14. Evaluation criteria

1. Elimination Criteria

The eliminatory criteria will focus on:

1. The absence of the bid bond;
2. False declaration or falsified document;
3. The absence of a quantified unit price in the "Financial Offer";
4. The technical score less than 70% of yes;
5. The absence of the purchase receipt from the DAO;
6. The absence of an administrative document after 48 hours from the day of the count.

7. Absence of the declaration on honor of not having abandoned a contract during the last five years.

On pain of rejection, the bid bond and the banker's statement of bank domiciliation must be produced in originals, the other documents in original or certified copies. These administrative justifications must be less than three (03) months old and conform to the models.

1. Essential criteria

The criteria relating to the qualification of the candidates will be indicative of:

1.	A table showing the balance of work over three years greater than or equal to the projected amount per year of the contract	yes/no
2.	Company references in similar achievements;	yes/no
3.	The experience of the technical support staff at the site (site staff);	yes/no
4.	Essential equipment (dump truck, small site tools and liaison vehicle)	yes/no
5.	The technical proposal: (Site installation, site organization chart, Team organization, hygiene measures)	yes/no
6.	A declaration on the honor of the bidder, signed and dated certifying the visit of the site	yes/no

Only tenderers with a score of at least 70% yes to the technical evaluation will be admitted to the analysis of the financial tender.

15. Assignment

The Contracting Authority will award the Contract to the Bidder whose bid has been found to be substantially compliant with the Bidding Documents and who has the technical and financial capacity to perform the Contract satisfactorily and whose bid has been evaluated the lowest, including any discounts offered.

16. Period of validity of the offers

Bidders will remain committed to their offers for 90 days from the deadline set for the submission of tenders.


