1. Subject of the invitation to tender:

Within the framework of the 2023 LINAfi Investment Budget, the **DIRECTOR OF LINAfi** hereby launches an Open National Invitation to Tender by **Emergency Procedure** FOR THE CONSTRUCTION OF A HANGAR FOR THE AQUACULTURE CONCRETE TANKS (PHASE II) IN LINAfi

2. NATURE OF WORK:

The works comprise groundwork (laying of foundation) as well as form work in accordance with the outcome of the preliminary studies carried out and the detailed information provided in the technical specifications. (*Document V*)

3. ALOTMENT:

The work is one lot;

4. ESTIMATED COST: The estimated cost after preliminary study is: 29,938,000 FCFA

5. PARTICIPATION AND ORIGIN:

The tender is open to duly legalized Cameroonian enterprises that fulfill the requirements of this invitation to tender.

6. SITE VISIT:

- It is important for all bidders to visit the site before tendering and to present a site visit report.

7. FINANCING:

The works which form the subject of this invitation to tender shall be financed by Public Investment **Budget of the 2023** financial year; Budget Head N^o: 222006

8. CONSULTATION OF THE TENDER FILE:

Interested eligible bidders may consult the file during working hours as from the date of publication of this tender notice, at the Secretariat of the *Director of LINAFI*

9. ACQUISITION OF TENDER FILE:

The complete tender file may be obtained from the Secretariat of the *Director of LINAFI* during working hours upon presentation of a treasury receipt attesting to the payment of a nonrefundable sum of: **50,000 FCFA** at the *Limbe Treasury*.

10. Bid bond

Each bidder must include in its administrative documents a bid bond issued by a first rate bank approved by the Ministry in charge of finance and recognized by COBAC (Commission Bancaire pour l'Afrique Centrale) featuring on the list in Document 12 of this tender file of an amount of : **598 760 FCFA**

NB: It is set at 2 % of the estimated amount, all taxes inclusive, and with a validity period of ninety (90) days from the date the bids are opened.

11. SUBMISSION OF BIDS (Venue, Date and Time):

Each bid drafted in English or French in *seven (07) copies* including the original and six (06) copies marked as such, should reach the Secretariat of the *Director of LINAFI* on **06/06/2023** at **12.00pm** local time and labeled.

NOTE: Any document poorly drawn-up, not bound as per Article 24 of the Public Contracts Code or not produced in Seven (7) copies shall be rejected.

12. ADMISSIBILITY OF OFFERS:

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender. They must obligatorily not be older than three (3) months preceding the date of submission of bids.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first rate bank approved by the Ministry in charge of finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid without any possibility of appeal.

13. OPENING OF BIDS (Place, Date and Time):

The bid shall be opened in a single (01) phase on 06/05/2023 at 1:00pm local time by the LINAFI Internal Tenders Board in the Conference Hall of School. Only bidders may attend or their duly accredited representatives with Power of Attorney.

15. EVALUATION CRITERIA

15.1: ELIMINATORY CRITERIA

Bids shall be rejected when:

- 1- absence of any administrative document
- 2- Any fake document, False declaration or forged document
- 3- Absent of quantified unit price
- 4- Duration of execution above three months
- 5- Technical score less than 70%

- 6- Absent or insufficient of bid bond

15.2: MAIN QUALIFICATION CRITERIA:

The criteria relating to the qualification of candidates will indicatively be on the following:

- 1- Financial capability
- 2- Enterprise's references
- 3- Methodology
- 4- Availability of material and essential equipment
- 5- Experience of supervisory staff

16. AWARD CRITERIA

- The jobbing order shall be awarded to the lowest bidder whose bids best fulfilled the Administrative; Technical and Financial conditions of this tender file.

NB: Minimum Technical Score is 70%

17. VALIDITY OF OFFERS:

Bidders shall be bound by their bids for a validity period of 90 (ninety) days with effect from the date of opening of bids.
