

Participation in this consultation is open to all Cameroonian entreprises with competences in security and an agreement according to the regulation in force.

4- Funding:

The subject works is financed by the equipment fund of the Directorate General of Taxation, imputation 44 71 01.

5- Estimated cost

The estimated cost is fourteen million three hundred ten thousand (14 310 000) FCFA all taxes included.

8 - Admissibility of offers

Each bidder must provide a bid bond amounting to **two hundred fifty thousand** (250,000) CFA franc with a validity period of thirty (30) days beyond the validity date of the tenders and established by an approved banking establishment by the Minister of Finance.

The required administrative documents must, under penalty of rejection, be produced in originals or in certified true copies by the issuing authority, dating less than three (03) months.

Any offer that does not comply with the requirements of this quotation request file will be declared inadmissible, in particular the absence of the bid bond, as well as that received after the deadline dates and times.

10 - Evaluation criteria

10.1 Eliminating criteria

- 1. Absence of bid bond
- 2.administrative file incomplete or not in accordance with the requirements of the consultation, 48 hours after the opening of the offers;
- 3. false declaration or forged document;
- 4. Absence of a sworn statement indicating that the tenderer has not been excluded from contracts in the last three years or is not under suspension from public contracts
- 5. Absence of references in the performance of two similar services of public building guardering by canine guards over the past 3 years and related documents (first and last page copy of the contract, copy of the page of the contract certifying that the service includes the canine guard Receipt report or certificate of good completion or good execution);
- 6. Absence of agreement signed by the competent Authority;
- 7. Omission in the financial offer of a quantified unit price;
- 8. technical score lower than 4/5 of YES of the essential criteria.

10.2 Essential criteria

The bid scoring system will be done by binary mode (yes/no) and will relate to the following criteria, the details of which are given in the RPAO:

- 1. general presentation of the offers (parts arranged in the order of the consultation file and separated by colored dividers);
- 2. proof of acceptance of the conditions of the consultation (CCAP and TOR stamped on each page, signed and dated on the last page);
- 3. proof of possession of 05 exotic purebred dogs trained in canine guard (attach proof of possession, including copy of vaccination records and photos);
- 4. means of transport: proof of possession of a vehicle adapted for secured transportation of dogs (attach a copy of the registration document certified by the transport services + photos of dogs);
- 5. personel: produce documents for 05 Dog Handlers (certified training diploma, CV dated and signed)

11. Allocation of the contract

The contract will be awarded to the bidder whose offer has been recognized as conforming essentially to the request for quotation and who has the technical and financial capacities required to perform the service satisfactorily and whose offer has been evaluated to be the lowest priced.

12- Duration and place of delivery

Delivery will take place at the headquarters of the Directorate General of Taxation, within a period of twelve (12) months from the date mentionned on the notification to commence.

13- Period of validity of offers

The bidders shall remain committed by their offers for 90 (ninety) days from the deadline set for the submission of bids.
