- ✓ Absence of the declaration on the honor of not-abandonment of a public contract during the three last years by the tenderer.

14.1.3. Financial bid

- ✓ Incomplete tender
- ✓ Parts no in conformity with the models contained in the CAD
- ✓ Absence of a quantified unit price
- ✓ Absence of a under-detail of the unit prices

14.2 Principal essential criteria

The evaluation of the technical Offers will be done by the binary method (yes/not) according to the grid of evaluation established on 34 criteria essential united with the CAD and which takes into account the essential criteria below:

- General presentation of the Offer; 02
- CCTP;1
- The experiment of the staff of the company; 08
- The availability of equipment and the essential equipment; 07
- Technical proposal and planning of completion of the work; 14
- References of the company and capacity of prefinancing of the Company 03

Only the Tenderers having obtained 70% of YES is 25/35 essential criteria will be qualified for the continuation of the procedure and will see their analyzed financial Offer.
