8. Admissibility of Offers:

Each bidder must include in his Administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No.12 of the tender file, of an amount of Six Hundred Thousand (600 000) CFA francs for a validity period of ninety (90) days from the date of opening.

On pain of being rejected, only originals or true copies certified by the issuing service or administrative authorities must imperatively be produced in accordance with the Special Regulations of the invitation to tender. They must obligatorily be not older than three (3) months preceding the date of submission of offers or may be established after the signature of the tender notice. Any offer not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Minister in charge of Finance or the non-respect of the models of the tender file documents shall lead to a pure and simple rejection of the offer.

9. Opening of Bids:

The offers shall be opened in single phase. The opening of Administrative Offers (Envelope A) the Technical Offers (Envelop B) and Financial Offers (Envelope C) on 5/3/2024 at 10 am local time by the Akwaya Council Tenders Board holding at the Akwaya Council Conference Hall.

### 11. Main eliminatory criteria


Bids shall be rejected when:

- > The technical offer must have at least (70%);
- > They lack one unit price;
- > Non conformity bid proper.
