1. Subject of the invitation to tender:

Within the framework of the 2024 Public Investment Budget, the *Lord Mayor of Limbe II Council* on behalf of the **MINISTER OF DECENTRALIZATION AND LOCAL DEVELOPEMENT** hereby launches an Open National Invitation to Tender by **Emergency Procedure, FOR THE CONSTRUCTION OF LOCKUP STORES MOKUNDANGE**

2. NATURE OF WORK:

The works comprise the outcome of the preliminary studies carried out and the detailed information provided in the technical specifications. (*Document V*)

3. LOTS:

The work is not in lot.

4. ESTIMATED COST: The estimated costs after preliminary study is **55,000,000 (FIFTY-FIVE MILLION) FCFA.**

5. PARTICIPATION AND ORIGIN:

The tender is open to duly legalized Cameroonian Enterprises that fulfill the requirements of this invitation to tender.

6. SITE VISIT:

It is important for all bidders to visit the site before tendering and to present a site visit report.

7. FINANCING:

The works which form the subject of this invitation to tender shall be financed by Public Investment Budget of the 2024 financial year; Budget Head N° 58 27 100 02 641931 523311

8. CONSULTATION OF THE TENDER FILE:

Interested eligible bidders may obtain further information during working hours as from the **date of publication of this tender notice at the private secretariat of the mayor's office Limbe II Council.**

9. ACQUISITION OF TENDER FILE:

The complete tender file may be obtained from the *Limbe II Council* upon presentation of a treasury receipt attesting to the payment of a nonrefundable sum of: **100,000 (ONE HUNDRED THOUSAND) FCFA** at the *Limbe II Municipal Treasury. (7:30am to 3:30pm).*

10. Bid bond

Each bidder must include in his/her administrative documents a bid bond issued by a first rate bank approved by the Ministry in charge of Finance and recognized by COBAC (Commission Bancaire pour l'Afrique Centrale) or Insurance company featuring on the list in Document 11 of this tender file of an amount of: **1,100,000 (ONE MILLION ONE HUNDRED THOUSAND) FCFA.**

NB: It is set at 2 % of the estimated amount, all taxes inclusive, and with a validity period of ninety (90) days from the date the bids are opened.

11. SUBMISSION OF BIDS (Venue, Date and Time):

Each bid drafted in English or French in *seven (07) copies* including one original and Six (06) copies marked as such, should reach the *Mayor's Office Limbe II Council* on or before **21/03/2024** at **9:00am** local time and labeled.

- Envelope A : Administrative Document ;
- Envelope B : Technical Document ;
- Envelope C : Financial Document.

NB: These three (03) envelopes shall be put in the forth envelope and shall be the only one to have the label mentioned overleaf

NOTE: Any document poorly drawn-up, not bound as per Article 24 of the Public Contracts Code or not produced in Seven (7) copies shall be rejected.

12. ADMISSIBILITY OF OFFERS:

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender. They must obligatorily not be older than three (3) months preceding the date of submission of bids.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first rate bank approved by the Ministry in charge of Finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid without any possibility of appeal.

13. OPENING OF BIDS (Place, Date and Time):

The bids shall be opened in a single (01) phase on **21/03/2024 at 10:00am** local time by the LIMBE II Council Internal Tender Board Office, located at the Limbe II Council building. Only bidders may attend or their duly accredited representatives with Power of Attorney.

14. DURATION OF EXECUTION: Three (03) months.

15. EVALUATION CRITERIA

15.1: ELIMINATORY CRITERIA

Bids shall be rejected when:

- 1- There's absence of Bid Bond in the administrative documents
- 2- Failure to present absent document in the administrative offer 48 hours after opening
- 3- There's any fake document, False declaration or forged document
- 4- There's absence of quantified unit price
- 5- Featuring on the MINMAP list of Enterprises that have abandoned public contract or ongoing contracts

15.2: MAIN QUALIFICATION CRITERIA:

The criteria relating to the qualification of candidates will indicatively be on the following:

16. AWARD CRITERIA

The Contract shall be awarded to the lowest bidder fulfilling the best technical and financial conditions.

17. VALIDITY OF OFFERS:

Bidders shall be bound by their bids for a validity period of 90 (ninety) days with effect from the date of opening of bids.

18. PUBLICATIONS; Publications shall be done through the; ARMP-SWR, and Notice Board of the Limbe II Council.
