## 14. Evaluation criteria

The aim of these criteria is to identify and reject incomplete offers or offers not in conformity with the essential conditions laid down in the tender file relating especially to admissibility of administrative documents, the conformity of the technical offer to the Terms of reference of the tender file and the qualification of candidates].

### Eliminatory criteria

The eliminatory criteria set the minimum conditions to be fulfilled in order to execute works subject of the tender. They should not be marked. They should be determined depending on the nature and the content of works to be executed.

#### Essential criteria

[These criteria are the fundamental or key ones that will help to measure the financial and the technical capacity of candidates wishing to execute the works subject of the tender. They should be determined depending on the nature and the content of the works to be executed.
