### 1- SUBJECT OF THE INVITATION TO TENDER

Within the framework of the execution of the Public Investment Budget (PIB) for the year 2024, the Makary Mayor Contracting Authority, here by launches IN EMERGENCY PROCEEDINGS, at the account of the Mayor of Makary, a national invitation to tender for SANITATION OF THE CITY OF MALTAM (section1 :Intersection road Fotokol -Crossroads chiefferie ; Section2 : Intersection road Fotokol- crossroads Buche shop ; Section3 : Crossroads Buches shop- EP MALTAM ; Section 4 : EP MALTAM- Intersection road FOTOKOL,in the Makary Council, Logone and Chari Divis

### 2- NATURE OF SERVICES

The works which shall be tendeed for the road works maintenance in Makary consists of task as enumerated in the estimations.

### 3- PARTICIPATION

Participation in this invitation to tender is open to companies specialised in public works located in Cameroon.

### 4-FINANCIONS

- 2- Public Investment Budget, 2024 financial year charge :  
Budgeted amount = 100 000 000 (Hundred millions) CFA francs ;

#### **5- CONSULTATION AND ACQUISITION OF TENDER FILE**

The file may be consulted and obtained from the mayor council located at Makary, as soon as this notice is published, against the payment of a non-refundable sum of 100 000 (One hundred thousand) CFA francs at the public municipal receipt.

#### **6- SUBMISSION OF OFFERS**

Each Offer drafted in English or French in 7 copies including one (1) original and six (6) copies marked as such, should reach the Logone and Chari divisional mayor council (Secretariat) located at Makary, not later than the 26/03/ 2024 at 10 am/pm local time and should carry the inscription.

#### **7- ADMISSIBILITY OF OFFERS**

Each bidder must include in his administrative documents, a bid bond issued by a first rate-bank approved by the ministry in charge of finance of an amount of Fifty hundred thousand and Two millions (2 000 000) CFA francs , valid for sixty (60) days from the date of bid-opening.

Under pain of being rejected, only originals or true copies certified by the issuing service

Or administrative authorities (senior Divisional officers, Divisional officers...) of the administrative documents required, including the bid bond, must imperatively be produced in accordance with the Special Conditions of the invitation to tender. They must obligatory not be older than three months or must not be produced after the signing of the tender file.

Any offer not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially, the absence of a bid bond issued by a first-rate bank approved by the ministry in charge of finance or the non-respect of the models of the

tender file documents shall lead to a pure and simple rejection of the offer without any appeal being entertained.

#### 8. Opening of bids

The bids shall be opened in one (01) phase.

The opening of administrative documents, the technical and financial offers shall take place on the 26/03/2024

At 11 am /pm local time by MAKARY council. Only bidders may attend or be duly represented by a person of their choice.

#### 9. Evaluation criteria

##### A- Main eliminatory criteria

###### 1-Administrative Offer

- 1) Absence of an administrative document ;
- 2) Counterfeit document ;
- 3) Non conformity of a document after the 48 hours regular extension

###### 2 Technical Offer

- 1) False declaration or counterfeit document :
- 2) Having abandoned a contract during the past three (03) years :
- 3) Having not gathered at least 75% of « yes » in qualification criteria.

###### 3) Financial Offer

- 1) Non conformity of the submission :
- 2) Absence in the unit price memo, of the price of the quantified task.

NB The certified copie of the previously legalized documents will be systematically rejected

##### B- Main qualification criteria

The criteria relation to the qualification of candidate are indicated as followed :

- 1) Access to a credit or other financial resources Yes/No ;
- 2) Supplier references Yes/No;
- 3) Experience of supervisory staff Yes/No ;
- 4) Availability of material and essential equipment Yes/No ;
- 5) Technical proposal( including methodology and expenditure schedule) Yes/No

Only bidders that technical Offers have received at least 75% of Yes will have their Financial Offers analyzed

#### 10- VALIDITY OF OFFERS

Bidders will remain committed to their Offers for sixty (60) DAYS from the date set for the delivery of Offers.

#### 11- BID BOND



The Offers should be accompanied by a bid bond issued by a first rate-bank approved by the Ministry in charge of Finance of and amount, that is two millions (2 000 000 ) CFA francs.

## 12- DELIVERY DEATLINE

The provisional delivery deatline provided for by the contracting Authority shall be sixty (60) days , including the possible constraints related to the site sitation such as accessibility and climate conditions,from the date of notification of service order to start works. It is due to the bidder to propose in his Offer a carrying out calendar that goes in the deadline indicated above.

## 13- ATTRIBUTION OF CONTRACT

The contract will be attributed to the bidder whose :

- 1- Administrative Offer will be declared conform ;
- 2- Technical Offer will be declared and have gathered at last 75% of Yes in qualification criteria ;
- 3- Financial Offer, after all corrections in conformity with the Particular Regulation of the invitation to tender, will be declared conform in relation to the Technical Clauses of the invitation to tender and classified the fewer proposition.
