**1. SUBJECT OF THE INVITATION TO TENDER**

The Mayor of Logone Birni council launches a consultation **for the equipment of poste agricole of Kidam in Logone Birni-subdivision, Logone and Chari division**

**2. PARTICIPATION**

Participation in this Invitation to tender shall be open to Cameroonian-based enterprises with experience in the domain.

**3. FINANCING**

Work subject to this invitation to tender shall be financed by the Public Investment budget 2024.

**4. CONSULTATION OF FILE**

The tender file may be consulted during working hours at the LOGONE BIRNI council, upon publication of this invitation to tender.

**5. ESTIMATED COST**

The estimated cost of the works is **6 000 000 FCFA**

**6 ACQUISITION OF THE TENDER FILE:**

The Tender files can be obtained during working hours from the LOGONE BIRNI council ( Procurement Service) against presentation of a **receipt for payment to the LOGONE-BIRNI Treasury council** a non-refundable sum of 10 000 (Ten thousand ) CFA francs, representing the cost of acquisition of the Tender files.

**6 SUBMISSION OF BIDS:**

Each offer drafted in English or French and seven (07) copies, one (01) original and six (06) copies marked as such, under seal, without indicating the identity of the bidder, subject to rejection, will achieve LOGONE BIRNI council (General secretariat), no later than **15/03/2024 at 13:00 a.m** local time deposited against a receipt and shall be labelled:

**7 TENDER COMPLIANCE**

Each bidder shall include in his/her administrative file, a provisional guarantee issued by a well-established bank, approved by the Ministry in charge of finance and whose list features in the Consultation File with a validity period of 30 (thirty) days beyond the original date of validity of bids to the tune of **FCFA 120 000 .**

Any other required administrative documents must be produced as original documents or photocopies certified as authentic by the issuing authority within the last three months or in course of validity, according to the listing provided for in the special regulations of the tender, otherwise they shall not be accepted.

Any bid not in compliance with the specifications of this tender notice and file shall be rejected. Notably, the absence of the provisional guarantee issued by a well-established bank approved by the Ministry in charge of Finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid.

**8 OPENING OF BID:**

The opening of the offer documents containing the administrative, technical and financial will be in one time. It will take place **on 15/02/2024 at 14H p.m.** local time. She will be in the LOGONE-BIRNI council office by the council Commission for Public Procurement sitting in the presence of bidders or their duly authorized representatives and having perfect knowledge of the case.

**9. EXECUTION DEADLINE:**

The deadline of execution set by the Contracting Authority shall be **60 DAYS LABOR**

**10. EVALUATION CRITERIA**

**MAIN ELIMINATORY CRITERIA:**

- Absence of Bid bond ;
- False declaration, falsified, forged documents ;
- Omission of a quantified unit price in the financial bid;
- Enterprise which is failing or hat abandoned works during tree (03) last years.

**11. ATTRIBUTION OF CONTRACT**

The contract shall be attributed to the lowest bidder and whose bid complies with the technical specifications.

**12. VALIDITY OF OFFERS:**

Bidders shall be bound by their bids for a period of ninety (90) days with effect from the date of opening of bids.
