6. Funding

Services which form the subject of this invitation to tender shall be funded by the PUBLIC INVESTMENT BUDGET of the Ministry of Decentralization and Local Development for the 2024 financial year, Budgetary Head: 58 27 100 02 641932 523316

7. Bid bond

Each bidder must include in his administrative documents, a bid bond by a first-rate issued banking establishment approved bv Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of 600 000 representing 2% of the project amount] and valid for thirty (30) days beyond the date of validity of bids

12. Admissibility of bids

Under pain of being rejected, only originals or certified true copies from the service administrative issuina or authorities (Senior Divisional Officers. Divisional Officers. etc.) documents required must imperatively be produced in accordance with the special conditions of the Invitation to tender. They must not be older than three (03) months.

Any bid not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge of Finance or the nonrespect of the models of the Tender File documents shall lead to outright rejection of the bid without appeal.

13. Opening of bids:

The bids shall be opened in a single (01) phase on the 23 OF 04 2024 at 11:00 am local time by the Tiko Council **Tenders** Board Internal in the Conference Hall of Tiko Council. Only bidders may attend or

represented by a duly mandated person.

14. Evaluation criteria

Evaluation criteria

Eliminatory Criteria i.

- In case of absence or non conformity of an administrative document, the bidder will be given 48 hours to produce or replace the document in question.
- (non conformity of administrative documents, technical offers and specifications)
- antecedents of bad execution of contracts etc (in conformity with letter No. circular 25TH 005/LC/MINMAP/CAB OF January 2017 relating to the taking into account the failures of companies in the execution of previous contracts in the attribution of new contracts.

- The technical score is less than the minimum required;
- It has any fake or forged document;
- Absence of quantified unit price.
- Non compliance with the model bid documents (Documents 9 and 10).
- It carries any false information.
- Less that 70% of the qualification criteria

ii. . Main Qualification criteria

The criteria for qualification of candidates should be on the following:

- Access to credit or other financial sources (15 million francs at least) Yes / No
- References of similar jobs; Yes / No
- Availability of material and essential equipment Yes / No
- Experience of supervisory staff Yes / No
- Methodology Yes/No
- Turnover as in business license above or equal to 15,000,000 million francs CFA;
- Qualified personnel relevant to the job.

Non-respect of two (02) of the above criteria shall entail rejection of the bid.

NB: the marking scale for bids by award of points is banned in favor of the binary method (Yes or No).

15. Award

The Contract shall be awarded to the contractor fulfilling the **best technical** and financial conditions.

16. Validity of bids

Bidders will remain committed to their bids for ninety (90) days from the deadline set for the submission of tenders
