Nature of services

The works comprise the outcome of the preliminary studies carried out and the detailed information provided in the technical specifications.

1. Execution deadline

The maximum deadline provided by the Project Owner or Delegated Contracting Authority for the execution of the works forming the subject of this invitation to tender is four (04) months.

4. Estimated cost

The estimated cost after preliminary studies is 23 000 000 FRS.

5. Participation and origin

Participation is open to duly legalized Cameroonian enterprises that fulfill the requirements of this invitation to tender.

6. Financing

Services which form the subject of this invitation to tender shall be funded by the Public Investment Budget of the 2024 financial year budgetary head 58.30 466 84

7. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of 460 000 FCFA and valid for thirty (30) days beyond the date of validity of bids

8. Consultation of tender file:

The file may be consulted during working hours at the Secretariat of the Mayor of Dikome Balue Council as soon as this notice is published.

9. Acquisition of tender file:

The file may be obtained from the secretariat of the Mayor of Dikome Balue Council as soon as this notice is published upon presentation of a treasury receipt attesting to the payment of a non-refundable fee of 30.000 FCFA, payable at the Dikome Balue Council Treasury.

10. Submission of bids:

11. Admissibility of bids

Under pain of being rejected, only originals or certified true copies from the issuing service or administrative authorities (Senior Divisional Officers, Divisional Officers, etc.) of the documents required must imperatively be produced in accordance with the special conditions of the Invitation to tender. They must not be older than three (03) months.

Any bid not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge of Finance or the non-respect of the models of the Tender File documents shall lead to outright rejection of the bid without appeal.

12. Opening of bids:

The bids shall be opened in a single (01) phase on the 3./9.5/2024 at 11am local time by the Tenders Board of the Contracting Authority in the Conference Hall of Dikome Balue Council. Only bidders may attend or their duly accredited representatives with Power of Attorney.

13. Evaluation criteria
