1. SUBJECT OF THE INVITATION TO TENDER

the Mayor of the Municipality of Belabo, contracting authority, launches on behalf of Belabo Council, an Open National Invitation to Tender in emergency procedure, for the work execution of the urban road maintenance for the Belabo Municipality (18 km), Lom and Djerem Division, East Region, for the year 2024 above-mentioned.

2. NATURE OF WORKS

The consistency of the work of this contract include:

- Preliminary works;
- Earthworks and road way;
- Sanitation works etc.;

3. EXECUTION DEADLINE

The maximum execution deadline provided for the Project Owner for the execution of the works, subject of this tender shall be **four (04) months**, from the date of notification of service order to start work.

4. ALLOTMENT

None object

5. ESTIMATED COST

The estimated cost of the operation following prior studies stands is: **65 000 000 (sixty five million) CFA F.**

6. PARTICIPATION AND ORIGIN

Participation in this invitation to tender is open to qualified contractors based in Cameroon, with the technical, financial and legal capacities to carry out the above described project.

7. FINANCING

Works which form the subject of this invitation to tender shall be financed by the public investment budget (PIB) of the Republic of Cameroon, Exercise 2024, Budget allocation N°58 36 12 60 16412064647118 61.

8. PROVISIONAL BID BOND

Each bidder must include in his administrative documents, a bid bond issued by a first rate-bank approved by the Ministry in charge of Finance featuring on the list in document 12 of the tender file of an amount of 1 300 000 (one million three hundred thousands) francs CFA, and valid for three (03) months beyond the original date of the validity of the offers.

9. CONSULTATION OF TENDER FILE

The Tender File can be consulted during working hours at Belabo municipality (Mayor's secretariat), after the publication of this notice.

10. ACQUISITION OF TENDER FILE

The Tender File may be obtained at Belabo municipality (Mayor's secretariat), as soon as this notice is published, against payment of a non refundable sum of 100 000 (one hundred thousand) francs CFA, payable to the Municipal Receipt of Belabo, as files charge.

11. SUBMISSION OF OFFERS

Each offer drafted in English or French in seven (7) samples, including the original and six (6) copies marked as such, should reach at Belabo municipality (Mayor's secretariat), not later than 21/05/2024 at 10 o'clock and should carry the inscription:

12. ADMISSIBILITY OF OFFERS.

Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the issuing service or an administrative authority (Senior Divisional Officer, Divisional Officer...) in accordance with the Special Conditions of the invitation to tender.

They must obligatory not be older than three months or must not be produced after the signing of the tender file.

Any incomplete offer in accordance with the prescriptions of this notice and tender file shall be declared inadmissible, especially the absence of a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

13. OPENING OF BIDS

The bids shall be opened in a single phase on 21/05/2024 at 11 o'clock, at the Conference Hall of the Belabo Council, in the presence of only bidders or be represented by a duly mandated person with a perfect knowledge of the file.
