#### 12. ADMISSIBILITY OF OFFERS:

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or certified true copies as authentic by the issuing authority or Administrative authorities (Senior Divisional Officer, Divisional Officer etc.) of the original documents required, in accordance with the Special Regulations of the Invitation to tender, they must not be more than three (03) months old.

Any bid not in compliance with the specifications of this notice and file tender shall be declared inadmissible. #### 14. EVALUATION CRITERIA:

The bids shall be evaluated according to the main criteria as follows:

Tender conformity shall be evaluated as per the following:

- Offers (bids) submitted after the deadline as per the following;
- ❖ Bids submitted in an unsealed envelope shall be rejected
- External envelopes with identification marks or inscriptions which may lead to the identification of the said company shall be rejected
- Absence of original or properly certified administrative document or documents certified more than one time shall be given 48 hours to replace it.
- Absence of bidbonds or certified check, Bqnk check, legal mortgage or Bank Guaranty or Bidbond not issued directly in biders name by a first rate bank approved by the ministry in charge of finance, the bidder shall simply be rejected.

NB: Bid bond for a group of enterprises must bear the name of mandated enterprise with the names the other enterprises mentioned as well.

II. Main qualification criteria:
