2. Nature of works

4. Allotment

8. Provisional bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first rate-bank approved by the Ministry in charge of Finance featuring on the list in document 12 of the tender file of an amount of

It shall equally be valid for thirty (30) days beyond the original date of the validity of the offers.

9. Consultation of tender file

The file may be consulted during working hours at the Internal Public Contracts Administrative Management Entity (SIGAMP) of the West Regional Council as soon as this notice is published.

10. Acquisition of tender file

The file may be obtained from West Regional Council as soon as this notice is published against payment of a non-refundable sum of 143 000 (one hundred forty three thousand) CFA francs payable at Regional Treasurer.

11. Submission of offers

Each offer drafted in English or French in seven (7) copies including the original and six (6) marked as

such, should be submitted at the West Regional Council not later than 25 JUN 2024 at 10 AM and should bear the following inscription:

12. Admissibility of offers.

Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the issuing service or an administrative authority (Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the issuing service or an administrative authority (Senior Divisional Officer, Divisional Officer...) in accordance with the Special Conditions of the invitation to tender.

They must not be older than three preceding the original date of submission of bids (3) months or must not have been established after the signing of the tender notice.

Any incomplete offer in accordance with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

NB. Under penalty of rejection by the services of the Contracting Authority (SIGAMP) at the time of submission, any candidate must present a copy of the receipt for the purchase of the tender file, the original of which is included in the offer.

13. Opening of bids

13.1 The bids shall be opened in single phase

The opening of the administrative documents, the technical and financial offers shall take place on 25 JUN 2024 at 11 AM to the West Regional Council in the meeting hall.

Only bidders may attend or be duly represented by a person of their choice.

The opening of the bid-opening session must be done not later than one hour after the time-limit for the submission of bids as specified in the tender file.

13.2. Bidders' discounts formulation (all DAO and DC)

- Discounts shall be mentioned in numbers and letters as of the opening of bids, to be admitted.

- Handwritten discounts (or presented with a typing shit different from the rest of the bidders offers) shall be rejected.
- And a proof of discount approved by the bidder shall be attached to the bid opening minute and to the analysis Subcommittee report.

14. Evaluation criteria

14.1. Eliminary criteria

The eliminary criteria set the minimum conditions to be fulfilled in order to execute works subject of the tender. They should not be marked. They should be determined depending on the nature and the content of works to be executed. These are:

- i) Missing or non-compliant administrative documents, not regularized within 48 hours;
- ii) Misrepresentation, falsified or non-authentic document ;
- iii) Non conformity with the submission model;
- iv) Omission of a quantified unit price in the financial offer;
- v) Technical score less than 70 points out of 100;
- vi) Absence of bid bond;
- vii) No commitment on the honor of never having abandoned market in the last three years;
- viii) Financial capacity less than or equal to one third of the estimated cost of the project;
- ix) Insufficient number documents;
- x) Having a 2023 project in progress by the bidder.

14.2. Essential criteria

The criteria relating to the qualification of candidates could indicatively be on the following:

I	Presentation:	(02criterea)
II	References ;	(05 criterea)
III	Personnel;	(12 criterea)
IV	Equipment:	(06 criterea)
V	Methodology :	(05 criterea)
VI	Financial bid :	(02 criterea)

Each bidder shall meet at least 23 yes/32 to be technically qualified.

15. Award

The contracting authority will award the contract to the bidder whose administrative offer is deemed compliant, meeting the required technical and financial capacities resulting from the essential criteria of the Tender Document, and which will be the lowest bidder at the evaluation of the financial offer.

16. Validity of offers

Bidders will remain committed to their offers for 90 days for NIT and 120 days for IIT from the deadline set for the submission of tenders.
