HEREBY DECIDES AS FOLLOWS

Article 1: NOBLE INVESTMENT COMPANY LIMITED, has been awarded the CONTRACT FOR THE SUPPLY AND DELIVERY OF MINERAL FERTILIZERS FOR THE CULTIVATION OF MAIZE. for the sum of ONE HUNDRED AND ONE MILLION SEVEN HUNDRED AND EIGHTEEN THOUSAND FOUR HUNDRED AND TWENTY- FIVE (107,718,425) FCFA VAT inclusive.

Article 2: THE SUPPLY AND DELIVERY OF MINERAL FERTILIZERS FOR THE CULTIVATION OF MAIZE shall be delivered within the duration of TWO (02) Months from the date of notification to start the supply and delivery.
