

## NOTICE OF NATIONAL TENDER IN EMERGENCY PROCEDURE

### **1- Purpose of the invitation to tender**

As part of the implementation of the 2024 Public Investment Budget, the PREFET OF UPPER-NKAM DIVISION, Contracting Authority, launches on behalf of the Ministry of Public Works a National Open Tender in emergency procedure for the rehabilitation of the road **SECTION NGUENACK – TOMCHI – NDOKOVI PHASE 1** *Bretelles: TOMCHI (Ancien petit marché) - NDOKOVI (Descente Quartier TETUH) (1,00km)* IN BAFANG, UPPER-NKAM DIVISION, WEST REGION.

### **2- Consistency of the work**

The work that is the subject of this Invitation to Tender includes the trades planned within the framework of the quantitative and estimated estimate.

### **3- Execution deadline**

The maximum execution deadline provided by the Contracting Authority for the provision of services is three (03) months. This period runs from the date of notification of the Service Order to start the work.

### **4- Allotment**

The works consist of a single lot here in after designated: rehabilitation works of the road **SECTION NGUENACK – TOMCHI – NDOKOVI PHASE 1** *Bretelles: Nguenack (stade municipal)- Ancienne maison de la femme et Mairie de Bafang - Délégation Jeunesse et Sport (1,00km)*, IN BANDJA, UPPER-NKAM DIVISION, WEST REGION

### **5- Participation and origin**

Participation in this Invitation to Tender is open on equal terms to Cameroonian companies established in Cameroon with proven experience in the field of Public Works and Building.

### **6- Estimated cost :**

The estimated cost of the operation following prior studies stand is **100 000 000 (One hundred millions) FCFA** all taxes

### **7- Financing**

The works covered by the Invitation to Tender are financed by the Public Investment Budget of the Ministry of Public Works, fiscal year 2024.

### **8- Provisional bid bond**

The provisional bid bond is **2 000 000 (Two millions) FCFA**. It will have to be established according to the model indicated in the tender file and delivered by a first class banking establishment or financial organization approved by the Ministry in charge of Finance and whose list appears in part 12 of this tender file and valid for thirty (30) days beyond the original date of validity of the offers.

Under pain of being rejected, the provisional bid bond must imperatively be produced in original dated less than three (03) months.



The provisional bid bond will be released no later than thirty (30) days after the expiry of the period of validity of tenders for unsuccessful tenderers. For the tenderer who receives the order letter, the provisional bid bond will be released after the establishment of the final bid bond.

#### **9- Consultation of tender file**

The tender file may be consulted during working hours at the UPPER-NKAM DIVISIONAL OFFICE and/or Public Works Delegation upon publication of this invitation to tender notice.

#### **10- Acquisition of the tender file**

Upon publication of this invitation to tender, the tender file can be obtained from the UPPER-NKAM DIVISION (Contracting Authority) upon presentation of the original of a receipt for payment to the **Upper-Nkam Treasury** of a non-refundable sum of **(100 000) one hundred thousand) CFA francs** representing the costs of acquiring the tender file.

#### **11- Submission of offers**

Each offer written in French or English and in seven (07) copies, including one (01) original and six (06) copies marked as such, must reach the UPPER-NKAM DIVISION, no later than ..... at 09 am precise against receipt and must bear the mention:

#### **12- Admissibility of offers**

Under penalty of rejection, the required administrative documents must be produced in originals or certified copies by the issuing services or an Administrative Authority, as the case may be, as indicated by the RPAO. They must be dated less than three (03) months before the opening of the bids or have been established after the original date of signature of the notice of invitation to tender.

Any incomplete offer in accordance with the prescriptions of the Tender Documents will be declared inadmissible, in particular the absence of the bid bond.

**N.B.:** Any offer presented after the time fixed for the deposit will not be opened and will be returned to the tenderer.

#### **13- Opening of tenders**

The bids will be opened in one time on ..... **from 10 am** precise by the Upper Nkam Division Procurement Commission attached to the Prefecture office in the presence of tenderers or their duly authorized representatives and having perfect knowledge of the files for which they are responsible.

#### **14- Evaluation criteria**

##### **14.1- Main eliminatory criteria**

- Absence of bid bond;
- False declaration, falsified document;
- Absence of an administrative document in the offer and not regularized within 48 (forty-eight) hours after the opening of the offers;
- Technical score below 70% (seventy percent) of all essential criteria or "YES";
- Non-respect of the conditions for article 6 of the tender;
- Omission in the financial offer of a quantified unit price;
- Enterprises whose have abandoned works.

#### 14.2- Essential criteria

- Financial situation;
- Enterprise's experience;
- Supervisors;
- Material resources made available to the project;
- Site visit;

#### 15- Attribution

The Contracting Authority will award the contracts to the tenderer whose offer has been evaluated as the lowest and which, in accordance with the Tender Documents, meets the required technical and financial capacities. Bidders presenting outliers (abnormally low) will be disqualified according to the prescribed regulatory procedure, namely obtaining the opinion of Public Contract Regulatory Agency (PCRA) after having first questioned the bidder concerned.

The recipient of the letter-order is invited to present himself upon signature of the award decision, at the latest within seven (07) days which follow and on pain of cancellation of said award decision, to the Upper- Nkam Division for the establishment and subscription of his letter-order.

**Failure for him to appear the contracts is assigned to the following.**

#### 16- Period of validity of offers

Bidders remain bound by their offers for a period of **90 (Ninety) days** from the deadline set for the submission of offers.

#### 17- Additional information.
