## 1. Subject of the Call for Offers:

Construction works of the solar energy borenole in the DDEPAT-BTOS in the BANGANGTE Sub Division, NDE Division, Western Region,

- 2. Scope of works:
- Construction and installation of one (01) borehole;
- Construction of a 5 m3 storage system, 10 m high, including all fittings;
- Supply and installation of a solar pump;
- Supply and installation of a discharge pipe, including all associated work;
- Connection of the distribution pipe to the delegation building;
- Disinfection and commissioning of the network;
- Awareness-raising and training of one (01) artisan repairer to maintain the work.

#### 3. Timeframe:

The maximum execution time planned by the project owner for the completion of the work is three (03) months.

#### 4. Allotments:

The work is subdivided into one lot.

#### 5. Estimated cost:

The estimated cost (including taxes) of the operation after preliminary studies is 15 000 000 (fifteen million) CFA francs for the first phase.

#### 6. Participation and origin

Participation in this Invitation to Tender is open to companies incorporated under Cameroonian law with expertise in the field of hydraulics.

# 7. Financing:

The work covered by this invitation to tender will be financed by the Public Investment Budget for fiscal year 2024.

#### 8. Provisional bond:

Each bidder must attach to its administrative documents a bid bond conforming to the attached model, issued by a first-class bank approved by the Ministry of Finance and listed in Exhibit 13 of the



DAO, in the amount of 300,000 (three hundred thousand) CFA francs and valid for 30 days beyond the original bid validity date.

## 9. Consultation of tender documents:

#### 12. Admissibility of Bids:
