TO AWARD THE CONTRACT UNDER LIMITED NATIONAL CALL FOR TENDERS No. 032/AONR/MINTP/CCCM-TR/CIPM-TCRI/2024 OF 25/04/2024, FOR THE EXECUTION OF WORKS TO CONSTRUCT THE MAMPANG - ANGOSSAS ROAD, 30 KM LONG, IN THE HAUT-NYONG DIVISION, EAST REGION. FINANCING: MINTP PUBLIC INVESTMENT BUDGET, FINANCIAL YEAR 2024 ET SEQ.

HEREBY DECIDES AS FOLLOWS:


Article 1: *The Limited National Call for Tenders No. 032/AONR/MINTP/CCCM-TR/CIPM-TCRI/2024 of 25/04/2024, for the execution of works to construct the Mampang - Angossas road, 30 km long, in the Haut-Nyong Division, East Region is hereby declared unsuccessful, as no tenderer met the requirements of the Tender Documents.*

Article 2: *Tenderers who applied for the above Call for Tenders may, within fifteen days, withdraw their tenders at the secretariat of the Internal Tenders Board for Infrastructure Construction and Rehabilitation Works. Beyond this deadline, these tenders shall be destroyed.*
