## 1. Object

## 2. Works

#### 9. Provisional surety

Each bidder must attach to their administrative documents, a bid bond established according to the model indicated in the Tender Document and in the amount of **Three hundred thousand** (300,000) CFA francs issued by one of the first-rate banks approved by the Minister responsible for Finance.

The provisional bond will be automatically released no later than one hundred and twenty (120) days after the publication of the results of the call for tenders for unsuccessful bidders. If the tenderer is successful, the provisional security will be released after the final security has been lodged.

## 10. Submission of Bids

Each offer written in English or French an in seven (07) copies whose one (01) original and six (06) copies marked like as, must be deposited to the Secretariat-general of the Dschang council, latest on **January 30**, 2025 at 10 a.m. standard time and have to be marked:

#### 11. Tender Compliance

Under penalty of rejection, the documents in the administrative file must be produced in originals or in copies certified true by the issuing department or an administrative authority (Governor, Prefect, Sub-Prefect, etc.), in accordance with the stipulations of the Special Rules of Appeal of Offers.

They must date from less than three (03) months preceding the original date of submission of tenders or have been dated after the date of signature of the Notice of Invitation to Tender.

Any incomplete bid in accordance with the requirements of the Call for Tenders Dossier will be declared inadmissible, in particular with regard to the absence of the bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

## 12. Opening of bids

Bids shall be opened in one phase. The Council Tenders Board at the Dschang Council shall open the administrative, technical and financial bids on **January 30, 2025, at 11 a.m**. local time.

The opening of the folds will be done in one time and in three stages:

- 1st step: opening envelope a containing the administrative documents (volume 1);
- 2nd step opening of envelope b containing the technical offers (volume 2);
- 3rd step opening of envelope c containing the financial offers (volume 3).

Each bidder can attend this opening session or be represented by a single person with a mandate duly signed by the director (even in the case of a group).

#### 13. Execution time

The maximum period specified by the Employer for the execution of the work referred to in this Request for Proposals is **three (03) months** from the date of notification of the service order to start the services.

## 14. Evaluation Criteria

#### 14.1 Eliminatory criteria

- Appear on the updated list of suspended companies;
- Obtain less than 70% (25 "yes" out of 36) of yes on the essentials criteria of technical offers;
- Omission of a quantify unit price:

- False statements or falsified documents;
- Certification of previously certified documents;
- Administrative file (no compliance of an administrative file) not completed in 48 h.

## 14.2 Essential criteria

The essential criteria are:

- The presentation of the offer (02 criteria);
- Supplier's references (05 criteria);
- Experience of supervisory staff (08 criteria);
- Material and essential equipment (12 criteria);
- The execution methodology, the planning, the site's visit report and proposals of execution (07 criteria);
- The financial offer of the candidate (02 criteria).

## 15. Attribution

The contracting authority shall award the contract to the lowest bidder in compliance with the tender file.

## 16. Validity of offers

Bidders shall be bound by their bids for a period of one hundred and ninety (90) days with effect from the date of opening of bids.
