1-Object of tender

The Mayor of DARAK launches in an emergency procedure, an Open National Invitation to Tender for the construction of two (02) mini drinking water supply at NGAIWA (lot 1) and BOUSSAYA (lot 2) Council, Logone and Chari Division, Far-North Region.

2-Allotment

The entire works are in two (02) lots as follow:

3. Consistance des travaux

4-Participation

Participation in this tender is open on equal terms with companies under Cameroonian law, justifying the technical capacities and financial resources to carry out the work covered by this tender.

5-Financing

Supplies which form the subject of this invitation to tender shall be financed by the PIB- MINWE for 2025 financial year for an estimated cost of twenty-fivemillion thousand 25 000 000) francs CFAIAT each lot

6- Consultation of the tender file

The File may be consulted during working hours at the DARAK Council in DARAK.

7- Acquisition of Tender File.

The file may be obtained from the DARAK Council as soon as this notice is published against payment in the DARAK Municipal Receipt of a non-refundable sum of fifty thousand (50 000) F CFA.

8. Presentation of the offer

The documents which constitute the are divided in three following volumes and contained in a closed and sealed envelope:

- The envelope A containing administrative documents (Volume 1) ;
- The envelope B containing technical offer (Volume 2) ;
- The envelope C containing financial offer (Volume 3).

The offer thus presented will be placed in a closed and sealed envelope bearing only the mention of the invitation to tender concerned. The different documents of each offer will be numbered according to the order of the tender file and separated by dividers of the same color.

9-Submission of offers

Each offer drafted in English or in French in seven (07) copies including the original and the five copies marked as such, should be deposited against a receipt duly signed in secretary of secretary of the Mayor of DARAK Council not later / 2025 at 1 a.m o'clock (local time) and should carry the inscription:

10-Admissibility of offers

Under pain of been rejected, only originals or true copies certified by issuing service or administrative documents authorities of the administrative document required, including the big bon must imperatively be produced in accordance with the special conditions of the invitation to tender. The most obligatorily not be older than three (03) months or must not be produced after the signing of the tender file.

Each bidder must include in his administrative documents a bid bon issued by a first rate-bank approved by the ministry of finance featuring on the list in document 9 of the tender file of amount of five hundred thousand (500 000) francs CFA per lot.

Any offer not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the ministry of Finance or the non-respect of the models of tender file documents shall lead to a pure and simple rejection of the offer without any appeal being entertained.

11-Opening of bids

The bids shall be opened in single and will be 03/ 02/2025 at 2 p.m local time by the DARAK Internal Tender's Board in the meeting room of DARAK Council

Only bidder may attend or be duly represented by a person of their choice you have a perfect knowledge of offers.

12- Delivery deadline

The delivery deadline provided by the Contracting Authority three months from the notification date of service order to beginning work.

13. Evaluation criteria

13.1- Eliminoirycriteria

14.1.1 : Administrative documents

- a. Incomplet offer after 48 hours given to the bidder ;
- b. Counterfeit or non genuine documents.
- c. Absence of bid bond

13.1.2 : Technical offer

- a. Technical file incomplete
- b. Misrepresentation;
- c. Not having justified a construction during the last 3 years, as principal contractor in concerned area ;
- d. Non existence in the technical offer in the heading « organisation, methodology and planning » ;
- e. Non satisfaction, at least eighteen (19) essential criteria over twenty-six (26).

13.1.4 : Financial offer

- a) Incomplet financial offer ;

- c) Omission in the financial offer of a quantified unit price ;
- d) Absence of a price subdetail.

13.2 : Essential criteria

L'évaluation of the technical offers will be based on 27 essential criteria as follow :

- a) General presentation over 3 criteria ;
- b) General experiences of the bidder 1 criteria
- c) Specific experiences of the bidder 1 criteria
- d) Management staff of the company 4 criteria ;
- e) Logistic means of the company 3 criteria
- f) Company equipments over 5 criteria ;
- g) Execution of methodology 2 criteria ;
- h) Security equipments 4 criteria.
- i) Organisation and execution of the tasks 2 criteria
- j) Turnover and financial capacity 2 criteria

14. Attribution of contract

The contract will be attributed to the bidder whose:

- Administrative offer will be declared conform;
- Technical offer will be declared conform and have gathered at least 80% of "Yes" in qualification criteria;
- Financial offer, after all corrections in conformity with the Particular Regulation of the invitation to tender, will be declared conform in relation to the Technical clauses of the invitation to tender, and classified the fewer proposition.

15- Validity of offers

Bidders will remain committed to their offers for 90 days from the deadline set for the submission.
