#### 1 - Introduction

Since 2019, the Government of Cameroon has been implementing the Agriculture Infrastructure and Value Chain Development Project (AIVDP) in the South West Region with financial support from the Islamic Development Bank. This Project is a follow up project to the Rumpi Area Participatory Development Project that was implemented in the Region from 2005 to 2012. The overall objective of the Project is to contribute to inclusive growth in the Region through enhanced agricultural productivity and value chain development. The development objectives are to: (i) increase incomes of smallholders and agriculture service providers; (ii) improve access to basic social/public services (WATSAN, education and health); and (iii) enhance the capacity (operational and institutional) of Farmers' Organizations (cooperatives for the most part) in undertaking rural development projects.

The M&E plan of the Project envisages several external assessments including a baseline study, a midterm review, a final evaluation and an impact assessment.

### Subject

The Coordinator of AIVDP hereby launches an Open National Invitation to Tender for the recruitment of a Consultancy Firm to carry out the final evaluation of the Project. Details of the selection procedure and services to be provided by the selected consultant are provided in the Terms of Reference.

## Participation:

This National Invitation to Tender is open to Cameroonian-based consultancy firms that have proven their ability and expertise in evaluating multilaterally funded agriculture and rural development projects.

**Financing** 

The consultancy which forms the subject of this invitation to tender shall be financed by AIVDP Government of Cameroon funds for the 2025 financial year.
