GENERAL RULES OF THE INVITATION TO TENDER

Article 1: Scope of the tender

- 1.1 The Contracting Authority as defined in the Special Regulations of the invitation to tender hereby launches an invitation to tender for the construction and/or completion of the works described in the Tender File and briefly described in the Special Regulations. The name, identification number and number of lots which form the subject of the invitation to tender feature in the Special Regulations of the invitation to tender.

Article 2: Financing

The source of financing of the works forming the subject of this invitation to tender shall be specified in the Special Regulations.

Article 3: Fraud and corruption

- The Contracting Authority requires of bidders and contractors the strict respect of rules of professional ethics during the award and execution of public contracts. By virtue of this principle:
 - The following definitions shall be admitted: a)
 - Shall be guilty of "corruption" whoever offers, gives, requests or accepts any advantage in view of influencing the action of a public official during the award or execution of a contract;
 - Is involved in "fraudulent manoeuvres" whoever deforms or distorts facts in order to influence the award or execution of a contract;
 - III. "Collusive practices" shall mean any form of agreement between two or among several bidders (whether the Contracting Authority is aware or not) aimed at artificially maintaining the prices of bids at levels not corresponding to those resulting from competition;
 - IV. "Coercive practices" shall mean any form of harm against persons or their property or threats against them in order to influence their action during the award or execution of a contract.
 - Any proposed award shall be rejected if it is proved that the proposed preferred bidder b) is directly or through an intermediary, guilty of corruption or is involved in fraudulent manoeuvres, collusive or coercive practices for the award of this contract.
 - The Minister Delegate at the Presidency in charge of public contracts may, as a precaution, 3.2 take a decision of exclusion from bidding for a period not exceeding two (2) years against any bidder found guilty of influence peddling, of conflicts of interest, insider trading, fraud, corruption or production of non-genuine documents in the bid, without prejudice to criminal proceedings that may be brought against him

Article 4: Candidates allowed to compete

4.1 If the invitation to tender is restricted, consultation is addressed to all candidates retained after a pre-qualification procedure.

- 4.2 Generally, the invitation to tender is addressed to all entrepreneurs, subject to the following provisions:
 - (a) A bidder (including all members of a group of enterprises and all sub-contractors to the bidder) must be from an eligible country, in accordance with the funding agreement.
 - (b) A bidder (including all members of a group of enterprises and all sub-contractors to the bidder) must not be in a situation of conflict of interest, subject to disqualification. A bidder shall be judged to be in a situation of conflict of interest if he:
 - is or was associated in the past with an enterprise (or a subsidiary of this enterprise) which
 provided consultancy services for the conception, preparation of specifications and other
 documents used within the scope of contracts awarded for this invitation to tender; or
 - ii) Presents more than one bid within the context of invitation to tender, except authorised variants according to article 17, where need be; meanwhile, this does not prevent the participation of sub-contractors in more than one bid.
 - iii) The Contracting Authority or Project Owner has financial interests in the capital in a way as to compromise the transparency of the procedures of award of public contracts.
 - (c) The bidder must not have been excluded from bidding for public contracts.
 - (d) A Cameroonian public enterprise may participate in the consultation if it can demonstrate that it is (i) legally and financially autonomous, (ii) managed according to commercial laws and (iii) not under the direct supervisory authority of the Contracting Authority or Project Owner.

Article 5: Building materials, materials, supplies, equipment and authorised services

- 5.1 Building materials, the contractor's materials, supplies, equipment and services forming the subject of this contract must originate from countries meeting the criteria of origin defined in the Special Regulations of the invitation to tender and all expenditure done within the context of the contract shall be limited to the said building materials, materials, supplies, equipment and services.
- 5.2 Within the meaning of this 5.1 above, the term "originate" shall designate the place where the goods are extracted, cultivated, produced, manufactured and from where the services originate.

Article 6: Qualification of bidder

- 6.1 As an integral part of their bid, bidders must:
 - (a) submit a power of attorney making the signatory of the bid bound by the bid; and
 - (b) Provide all information (complete or update information included in their request for prequalification which may have changed in the case where the candidates took part in prequalification) requested of bidders in the Special Regulations of the invitation to tender, in order to establish their qualification to execute the contract.

Where necessary, bidders should provide information relating to the following points:

- (i) The production of certified balance sheets and recent turnovers;
- (ii) Access to a line of credit or availability of other financial resources;
- (iii) Orders acquired and contracts awarded;
- (iv) Pending litigations; and
- (v) Availability of indispensable equipment.

- 6.2 Bids presented by two or more associated undertakings (joint-contracting) must satisfy the following conditions:
- (a) The bid must include all the information listed in article 6(1) above. The Special Regulations must indicate the information to be furnished by the group and that to be furnished by each member of the group;
- (b) The bid and the contract must be signed in a way that is binding on all members of the group;
- (c) The nature of the group (joint or several) must be specified in the Special Regulations and justified with the production of a joint venture agreement in due form;
- (d) The member of the group designated as the representative will represent all the undertakings vis à vis the Project Owner and Contracting Authority with regard to the execution of the Contract;
- (e) In case of joint co-contracting, the co-contractors shall share the sums which are paid by the Project Owner into a single account. On the other hand, each undertaking is paid into its own account by the Project Owner where it is joint co-contracting.
- 6.3 Bidders must equally present sufficiently detailed proposals to demonstrate that they comply with the technical specifications and execution time-limits set in the Special Regulations of the invitation to tender.
- 6.4 Bidders requesting to benefit from the margin of preference must furnish all the necessary information to prove that they satisfy the eligibility criteria set in article 33 of the General Regulations of the invitation to tender.

Article 7: Visit of works site

- 7.1 The bidder is advised to visit and inspect the site and its environs and obtain by himself and under his own responsibility, all the information which may be necessary for the preparation of the bid and the execution of the works. The related cost of the visit of the site shall be borne by the bidder.
- 7.2 The Project Owner shall authorise the bidder and his employees or agents to enter the premises and the land for the said visit but only on the express condition that the bidder, his employees and agents free the Project Owner, his employees and agents of any responsibility that may ensue and indemnify them if necessary and that they shall remain responsible for any deadly or corporal accident, loss or material damages, costs and fees incurred from this visit.
- 7.3 The Project Owner may organise a visit of the site of the works during the preparatory meeting to establishing the bids mentioned in article 19 of the General Regulations of the invitation to tender.

B. Tender File

Article 8: Content of Tender File

- 8.1 The Tender File describes the works forming the subject of the contract, sets the consultation procedure of contractors and specifies the terms of the contract. Besides the addendum (addenda) published in accordance with article 10 of the General Regulations of the invitation to tender, it includes the following documents:
 - Document No. 1. The letter of invitation to tender (for restricted invitation to tender);
 - Document No. 2. The tender notice;
 - Document No. 3. The General Regulations of the invitation to tender;
 - Document No. 4. The Special Regulations of the invitation to tender;
 - Document No. 5. The Special Administrative Conditions;
 - Document No. 6. The Special Technical Conditions;
 - Document No. 7. The schedule of unit prices;
 - Document No. 8. The bill of quantities and estimates;
 - Document No. 9. The sub details of unit prices;
 - Document No. 10. Model documents of the contract:
 - a. The execution schedule;
 - b. Model of forms presenting the equipment, personnel and references;
 - c. Model bidding letter;

- d. Model bid bond;
- e. Model final bond;
- f. Model of bond of start-off advance;
- g. Model of guarantee in replacement of the retention fund;
- h. Model contract;

Document No. 11. Models to be used by bidders;

a. Model contract;

Document No. 12. Justifications of preliminary studies; to be filled by the Project Owner or Delegated Project Owner;

Document No. 13. List of first grade banking establishments or financial institutions approved by the Minister in charge of Finance authorised to issue bonds for public contracts to be inserted by the Contracting Authority.

8.2 The bidder must examine all the regulations, forms, conditions and specifications contained in the Tender File. It is up to him to furnish all the information requested and prepare a bid in compliance with all aspects of the said file.

Article 9: Clarifications on the Tender File and complaints

9.1 Any bidder who wants to obtain clarifications on the Tender File may request them from the Contracting Authority in writing or by electronic mail (fax or e-mail) at the Contracting Authority's address indicated in the Special Regulations of the invitation to tender and send a copy to the Project Owner. The Contracting Authority replies in writing to any request for clarification received at least fourteen (14) days prior to the deadline for the submission of bids.

A copy of the Contracting Authority's response, indicating the question posed but not mentioning the author, is addressed to all bidders who bought the Tender File.

- 9.2 Between the publication of the tender notice including the pre-qualification phase of candidates and the opening of bids, any bidder who feels aggrieved in the public contracts award procedure may lodge a complaint to the Minister in charge of Public Contracts.
- 9.3 A copy of the complaint should be addressed to the Contracting Authority and to the body in charge of the regulation of public contracts and the chairperson of the Tenders Board.
- 9.4 The Contracting Authority has five (5) days to react. A copy of the reaction shall be forwarded to MINMAP and the body in charge of the regulation of public contracts.

Article 10: Amendment of the Tender File

- 10.1 The Contracting Authority may at any moment, prior to the deadline for the submission of bids and for any reason, be it at his initiative or in reply to a request for clarification formulated by a bidder, amend the Tender File by publishing an addendum.
- 10.2 Any published addendum shall be an integral part of the Tender File, in accordance with article 8.1 of the General Regulations of the invitation to tender and must be communicated in writing or made known by a traceable means to all bidders who bought the Tender File.
- 10.3 In order to give bidders sufficient time to take account of the addendum in the preparation of their bids, the Contracting Authority may postpone as is necessary, the deadline for the submission of bids, in accordance with provisions of article 22 of the General Regulations of the invitation to tender

C Preparation of bids

Article 11: Tender costs

The candidate shall bear the costs related to the preparation and presentation of his bid and the Contracting Authority and the Project Owner shall in no case be responsible for these costs nor pay for them whatever the evolution or outcome of the invitation to tender procedure.

Article 12: Language of bid

The bid as well as any correspondence and any document exchanged between the bidder and the Contracting Authority shall be written in English or French. Complementary documents and the forms provided by the bidder may be written in another language on condition that a precise translation into either English or French of the passages concerning the bid is included; in which case for reasons of interpretation, the translation shall be considered to be authentic.

Article 13: Constituent documents of the offer

13.1 The offer presented by the bidder shall include the documents detailed in the Special Regulations of the invitation to tender, duly filled and put together in three volumes:

Volume 1: Administrative documents

They include:

- I. All documents stating that the bidder:
 - > Has complied with all declarations provided for by the laws and regulations in force;
 - > I current with his taxes, contributions, fees or levies of any kind whatsoever;
 - > Is not in a State of liquidation or bankruptcy;
 - > Is not struck by one of the prohibitions and disqualifications criteria provided for by the legislation in force.
- II. Bid bond(s) issued is are in conformity with the provisions of article 15 of the present RGAO;
- III. A written confirmation authorizing the signatory of the offer to engage the bidder
- IV. The CCAP is duly initialed on each page and signed on the last page.
- V. Localization plan is duly signed by the authority concern.

b. Volume II: Technical Offer

It includes:

- References of the company (the contractor will provide contracts or Jobbing orders for similar work carried out as well as related minutes of reception);
- II. Personnel: the contractor will present the competent technical staff and workers he intends to employ before the beginning of the work (attach to each staff CV signed by the candidate, certified copy of technical diploma attestation of presentation of original of the technical diploma, and the attestation of availability signed by the candidate);
- III. Site equipment: The contractor shall justify the ownership and the State of the equipment necessary for the performance of the work (providing registration certificates, invoices and certificates of road worthiness (visit technique) of rolling equipment;
 - IV. The technical note on the methodology of intervention of the work: the company will produce a technical note dated and signed providing all the information concerning the mode of execution of the works, the execution plan of the expected output, provision of materials or site materials, the potential advantages in terms of safety of the environment and the Organization of the company,
 - V. Attestation of site visit and the site visit report;
 - Vi The CCTP duly initialed on each page and signed on the last page
- Vii Attestation of solvency of the contractor.

c. Volume 3: Financial offer

It includes:

- I. The submission letter, in original drafted according to the model attached, stamped at the rate in force, signed and dated;
- II. The unit price schedule duly completed, with an indication of the unit price excluding VAT in letters and figures;
 - III. Detail Bill of Quantities and cost estimate of the work completed;
 - IV. Sub-details of the different prices according to the model attached;

In this regard, the bidders will use the documents and models provided in the Tender File, subject to the provisions of article 17(1) of the General Regulations of the invitation to tender concerning the other possible forms of guarantees.

13.2 If in accordance with the provisions of the Special Regulations of Invitation to Tender, the bidders present offers for several lots of the same invitation to tender, they could indicate rebates offered in case of award of more than one lot.

Article 14: Bid price

- 14.1 Except otherwise stated in the Tender File, the amount of the contract shall cover all the works described in article 1.1 of the General Regulations of the invitation to tender, on the basis of the price schedule and the detailed bill of quantities and estimates presented by the bidder.
- 14.2 The bidder shall fill the unit prices and totals of all items on the schedule and bill of quantities and estimates.
- 14.3 Subject to contrary provisions provided for in the Special Regulations and in the Special Administrative Conditions, all dues, taxes and fees payable by the bidder on grounds of the contract or on any other ground, thirty (30) days prior to the submission of the bids, shall be included in the prices and in the total amount of the bid presented by the bidder.
- 14.4 If a price revision/updating clause is provided for in the contract, the date of establishment of the initial price, as well as the price revision/updating conditions for the said price must be specified. This is with the understanding that any contract of duration less than one (1) year shall not be subject to price revision.
- 14.5 All unit prices must be justified by sub-details established in accordance with the structure proposed in document 8 of the Tender File.

Article 15: Currency of bid and payment

- 15.1 In case of international invitations to tender, the currencies of the bid shall follow the provisions of either Option A or Option B below, the applicable option being that retained in the Special Regulations of the invitation to tender.
- **15.2 Option A:** The amount of the bid shall be entirely made in the national currency. The amount of the bid, unit prices of the price schedule and the prices of the bill of quantities and estimates are completely made in CFA francs in the following manner:
 - a) Prices shall be entirely drawn in the national currency. The bidder who intends to commit expenditures in other currencies for the execution of the works shall indicate in the annex to the bid the percentage(s) of the amount of the bid necessary to cover the needs in foreign currencies, without exceeding the maximum of the three currencies of member countries of the funding institution of the contract.
 - b) The exchange rates used by the bidder to convert his bid into the national currency shall be specified by the bidder in an annex to the bid in compliance with the specifications of the Special Regulations. These rates shall be applied for any payment within the framework of the contract so that the retained bidder does not bear any change in the exchange rate.
- **15.3 Option B:** The amount of the bid shall be directly made in the national and foreign currency at the rates fixed in the Special Regulations.

The bidder shall draw the unit prices of the price schedule and the prices of the bill of quantities and estimates in the following manner:

- (a) The prices of inputs necessary for the works which the bidder intends to procure in the Contracting Authority's country shall be in currency of the Contracting Authority's country specified in the Special Regulations and called "national currency";
- (a) The prices of inputs necessary for works which bidder intends to procure out of the Contracting Authority's country shall be in the currency of the country of origin of the bidder or of the currency of an eligible member country widely used in international trade.
- 15.4 The Contracting Authority may request the bidders to explain the needs in national and foreign currencies and to justify that the amounts included in the unit and total prices and indicated in annex to the bids are reasonable; to this end, a detailed statement of their needs in foreign currencies shall be furnished by the bidder.
- 15.5 During the execution of the works, most of the foreign currency to be paid as part of contract may be revised by mutual agreement between the Contracting Authority and the entrepreneur in a way as take account of any modification in the foreign currency needs within the context of the contract.

Article 16: Validity of bids

- 16.1 Bids must remain valid during the period stated in the Special Regulations from the date of submission of the bids fixed by the Contracting Authority, in application of article 22 of the Special Regulations. A bid valid for a shorter period shall be rejected by the Contracting Authority or Delegated Contracting Authority as not being in compliance.
- 16.2 Under exceptional circumstances, the Contracting Authority may seek the approval of bidders to extend the validity time-limit. The request and the responses that will be given shall be in writing (or by fax). The validity of the bid bond provided for in article 17 of the General Regulations shall equally be extended for a corresponding duration. A bidder may refuse to extend the validity of his bid without losing his bid bond. A bidder who consents to an extension shall not be asked to modify his bid nor shall he be authorised to do so.
- 16.3 Where the contract does not include a price revision clause and that the period of validity of bids is extended by more than sixty (60) days, the amounts payable to the bidder retained shall be updated by application of the related formula featuring in the request for extension that the Contracting Authority addressed to bidders.

The updating period shall run from the date of overrun of sixty (60) days to the date of notification of the contract or the Administrative Order for start of execution of works by the retained bidder, as specified in the Special Administrative Conditions. The effect of updating shall not be taken into account for purposes of evaluation of bids.

Article 17: Bid bond

- 17.1 In application of article 13 of the General Regulations, the bidder shall furnish a bid bond of the amount specified in the Special Regulations and which bid bond shall be a full part of his bid.
- 17.2 The bid bond must conform to the model presented in the Tender File; other models may be authorised subject to the prior approval of the Contracting Authority. The bid bond will remain valid for thirty (30) days beyond the original date set for the validity of bids or any other validity time-limit requested by the Contracting Authority and accepted by the bidder, in accordance with the provisions of article 16 (2) of the General Regulations.
- 17.3 Any bid without an acceptable bid bond shall be rejected by the Tenders Board as not in conformity. The bid bond of associated enterprises must be established in the name of the group submitting the bid and mention each member of the associated grouping.
- 17.4 The bid bonds of bidders who are not retained shall be returned within fifteen (15) days after publication of the award result.

- 17.5 The bid bond of the successful bidder shall be released as soon as the latter would have signed the contract and furnished the required final bond.
- 17.6 The bid bond may be seized:
 - (a) if the bidder withdraws his bid during the period of validity;
 - (b) if the retained bidder:
 - i) fails in his obligation to register the contract in application of article 38 of the General Regulations;
 - fails in his obligation to furnish the required final bond in application of article 38 of the General Regulations;
 - Refuses to receive notification of the Administrative Order to commence execution.

Article 18: Varying proposals of bidders

- 18.1 Where the works can be executed within variable deadlines, the Special Regulations shall specify these deadlines and shall indicate the method retained for the evaluation of the completion deadline proposed by the bidder within the specified deadlines. Bids that propose deadlines beyond those specified shall be considered as not being in conformity.
- 18.2 Except in the case mentioned in article 18(3) below, bidders wishing to offer technical variants must first assess the basic solution of the Contracting Authority as described in the Tender File and furnish in addition all the information which the Contracting Authority needs for a complete evaluation of the proposed variant, including the plans, calculations, technical specifications, sub-details of prices and proposed construction methods and all other useful information. If necessary, the Contracting Authority will examine only the technical variants of the bidder whose bid is in compliance with the basic solution has been evaluated as the lowest bid.
- 18.3 When according to the Special Regulations the bidders are authorised to directly submit the technical variants for certain parts of the works, these parts of the works must be described in the technical specifications. Such variants shall be evaluated on their own merit in accordance with the provisions of article 31(2) (g) of the General Regulations.

Article 19: Preparatory meeting to the establishment of bids

- Except otherwise stipulated in the Special Regulations, a bidder may be invited to take part in a preparatory meeting which will hold at the date and place indicated in the Special Regulations.
- 19.2 The subject of the preparatory meeting shall be to furnish clarifications and answer any questions which may be raised at this stage.
- As much as possible, the bidder is requested to submit any question in a way as to reach the 19.3 Contracting Authority at least one week before the meeting The Contracting Authority may not reply to questions received too late. In this case, the questions and answers shall be transmitted according to the methods set in article 19(4) below.
- The minutes of the meeting, including the text of the questions asked and the replies given, including questions prepared after the meeting, shall be forwarded immediately to everyone who bought the Tender File. Any modification of documents of the Tender File listed in article 8 of the General Regulations which may prove to be necessary at the end of the preparatory meeting shall be done by the Contracting Authority by publishing an addendum in accordance with the provisions of article 10 of the General Regulations and not through the minutes of the preparatory meeting.
- 19.5 The fact that a bidder does not attend a preparatory meeting for the establishment of bids shall not be a reason for disqualification.

Article 20: Form and signature of bid

- 20.1 The bidder shall prepare an original of the constituent documents described in article 13 of the General Regulations in a volume clearly indicated "ORIGINAL". In addition, the bidder shall submit the number required in the General Regulations, bearing "COPY". In case of discrepancy, the original shall be considered as authentic.
- 20.2 The original and copies of the bid must be typed or written in indelible ink (photocopies shall be accepted in the case of copies) and shall be signed by the person(s) duly empowered to sign on behalf of the bidder, in accordance with article 6(1a) or 6(2c) of the General Regulations, as the case may be. All the pages of the bid containing alterations or changes must be initialled by the signatory (ies) of the bid.
- 20.3 The bid shall be bear no modification, suppression or alteration unless such corrections are initialled by the signatory (ies) of the bid.

D. SUBMISSION OF BIDS

Article 21: Sealing and marking of bids

- 21.1 The bidder shall seal the original and each copy of the bid in separate envelopes (internal envelopes) by marking on these envelopes "ORIGINAL" and "COPY", as the case may be. The envelopes shall then be placed in another envelope which will equally be sealed but which will not give any indication regarding the identity of the bidder.
- 21.2 The external and internal envelopes:
 - a) should be addressed to the Contracting Authority at the address indicated in the Special Regulations;
 - b) should bear the name and identification number of the project as indicated in the Special Regulations and bear the inscription "TO BE OPENED ONLY DURING THE BID-OPENING SESSION" as specified in the Special Regulations.
- 21.3 The internal envelopes should equally carry the name and address of the bidder in a way as to enable the Contracting Authority return the sealed bid if it is late in accordance with article 23 and 24 of the General Regulations.
- 21.4 If the external envelope is not sealed and marked as indicated in paragraphs 21(1) and 21(2) above, the Contracting Authority shall not be responsible if the bid is misplaced or opened prematurely.

Article 22: Date and time-limit for submission of bids

- 22.1 The bids must be received by the Contracting Authority at the address specified in article 21(2) of the Special Regulations not later than the date and time stated in the Special Regulations.
- 22.2 The Contracting Authority may, at his discretion, postpone the deadline set for the submission of the bids by publishing an addendum in accordance with the provisions of article 10 of the General Regulations. In this case, all the rights and obligations of the Contracting Authority and bidders previously governed by the initial date will henceforth be governed by the new date.

Article 23: Late bids

Any bid received by the Contracting Authority beyond the deadline for the submission of bids in accordance with article 22 of the General Regulations shall be declared late and consequently rejected.

Article 24: Modification, substitution and withdrawal of bids

24.1 A bidder may modify or withdraw his bid after submitting it, on condition that the written notification of the modification or withdrawal is received by the Contracting Authority prior to the end of the time-limit prescribed for the submission of the bids. The said notification must be signed by an authorised representative in application of article 20(2) of the General Regulations. The modification or the corresponding replacement bid must be attached to the written notification. As the case may be, the

envelopes must bear the inscription "WITHDRAWAL", and "REPLACEMENT BID" or "MODIFICATION".

24.2 Notification of modification, replacement or withdrawal of the bid by the bidder should be prepared, sealed, marked and forwarded in accordance with the provisions of article 21 of the General Regulations. Withdrawal may equally be notified by telex but should in this case be confirmed by a duly signed written notification whose date, post mark being authentic, shall not be posterior to the time-limit set for the submission of bids.

- 24.3 In application of article 24(1), bids being requested to be withdrawn by bidders shall be returned to them unopened.
- 24.4 No bid may be withdrawn during the interval between the submission of bids and the expiry of the validity of bids specified by the model tender. The withdrawal of a bid by a bidder during this interval may lead to the confiscation of the bid bond in accordance with the provisions of article 17(6) of the General Regulations.

E. Opening of envelopes and evaluation of bids

Article 25: Opening of envelopes and petitions

- 25.1 The competent Tenders Board shall open the envelopes in single or double phases and in the presence of the representatives of bidders who wish to attend at the date, time and address specified in the Special Regulations. Representatives of bidders shall sign a register attesting to their presence.
- 25.2 Firstly, envelopes marked "withdrawal" shall be opened and the contents announced to the hearing of everyone, while the envelope containing the corresponding bid shall be returned to the bidder unopened. Withdrawal shall be allowed only if the corresponding notification contains a valid empowerment of the signatory to request this withdrawal and if this notification is read to the hearing of everyone. Then the envelopes marked "Replacement bid" are opened and announced to the hearing of everyone and the new corresponding bid substituted for the preceding one which will be sent to the bidder concerned unopened. The replacement of the bid shall only be allowed if the corresponding notification contains a valid empowerment of the signatory requesting the replacement and read to the hearing of everyone. Lastly, the envelopes marked "modification" shall be opened and their contents read to the hearing of everyone with the corresponding bid. The modification of the bid shall only be allowed if the corresponding notification contains a valid empowerment of the signatory requesting the modification and read to the hearing of everyone. Only bids which were opened and announced to the hearing of everyone during the opening of bids shall then be evaluated.
- 25.3 All envelopes shall be opened successively and the name of the bidder announced aloud as well as the possible modification mentioned, the price offered, including any rebates [in case of opening of financial bids] and any variant, where necessary, the existence of a guarantee of the bid if it is required and any other details which the Contracting Authority deems useful to be mentioned. Only rebates and variants of bids announced to the hearing of everyone during the opening of bids shall be submitted for evaluation.
- 25.4 Bids (and modifications received in accordance with the provisions of article 24 of the General Regulations) which were not opened and read to the hearing of everyone during the bid-opening session for whatever reason, shall not be submitted for evaluation.
- 25.5 Bid-opening minutes are recorded on the spot mentioning the admissibility of bids, their administrative regularity, prices, rebates and time-limits as well as the composition of the Evaluation sub-committee. A copy of the said minutes to which is attached the attendance sheet is handed over to all the participants at the end of the session.

- 25.6 At the end of each bid-opening session, the chairperson of the Tenders Board immediately hands over to the focal point designated by the body in charge of regulation of public contract an initialled copy of the bids presented by bidders.
- 25.7 In case of petition as provided for by the Public Contracts Code, it should be addressed to the Minister Delegate in charge of Public Contracts with a copies to the body in charge of the regulation of public contracts, the head of structure to which is attached the Tenders Board concerned.

It must reach within a maximum deadline of three (3) working days after the opening of bids in the form of a letter to which is obligatorily attached a sheet of the petition form duly signed by the petitioner and possibly by the chairperson of the Tenders Board.

The Independent Observer attaches to his report the sheet that was handed to him, including any related commentaries or observations.

Article 26: Confidential nature of the procedure

- 26.1 No information relating to the examination, clarification, evaluation and comparison of bids and verification of the qualification of the bidders and the recommendation for the award shall be given to bidders or to any person not concerned with the said procedure as long as the preferred bidder has not been made public, subject to the disqualification of the bid of the bidder and suspension of the authors from all activities in the domain of public contracts.
- 26.2 Any attempt by a bidder to influence the Tenders Board or the Evaluation sub-committee of bids or the Contracting Authority in its award decision may lead to the rejection of his bid.
- 26.3 Notwithstanding the provisions of paragraph 26.2 above, between the opening of bids and the award of the contract, if a bidder wishes to enter into contact with the Contracting Authority for reasons having to with his bid may do so in writing.

Article 27: Clarifications on the bids and contact with the Contracting Authority

- 27.1 To ease the examination, evaluation and comparison of bids, the Tenders Board may, if it so desires, request any bidder to give clarifications on his bid. This request for clarification and the response thereto are formulated in writing but no change on the amount or content of the bid is sought, offered or authorised, except it is necessary to confirm the correction of calculation errors discovered by the Evaluation Sub-committee during the evaluation in accordance with the provisions of article 30 of the General Regulations.
- 27.2 Subject to the provisions of paragraph 1 above, bidders shall not contact members of the Tenders Board and the Evaluation Sub-committee for questions related to their bids, between the opening of envelopes and the award of the contract.

Article 28: Determination of compliance of bids

- 28.1 The Evaluation sub-committee shall carry out a detailed examination of bids to determine if they are complete, if the required guarantees are furnished, if the documents were correctly signed and if generally the bids are in proper order.
- 28.2 The Evaluation sub-committee shall determine if the bid is essentially in compliance with the conditions fixed in the Tender File based on the content without recourse to external elements of proof.
- 28.3 A bid that complies with the Tender File shall essentially be a bid that respects all the terms, conditions and specifications of the Tender File, without substantial divergence or reservation. A substantial divergence or reservation is that:
 - i) which substantially limits the scope, quality or realisation of the works;
 - ii) which substantially limits, contrary to the Tender File, the rights of the Contracting Authority or his obligations in relation to the contract;

- iii) Whose correction would unjustly affect the competitiveness of the other bidders who presented bids that essentially complied with the Tender File?
- 28.4 If a bid is essentially not in compliance, it shall be rejected by the competent Tenders Board and shall not subsequently be rendered in compliance.
- 28.5 The Contracting Authority reserves the right to accept or reject any modification, divergence or reservation. Modifications, divergences, variants and other factors which are beyond the requirements of the Tender File shall not be considered during the evaluation of bids.

Article 29: Qualification of the bidder

The Evaluation sub-committee shall ensure that the successful bidder retained for having submitted a bid substantially in compliance with the provisions of the Tender File, fulfils the qualification criteria stipulated in article 6 of the Special Regulations. It is essential to avoid any arbitrariness in determining qualification.

Article 30: Correction of errors

- 30.1 The Evaluation sub-committee shall verify bids considered essentially in compliance with the Tender File to correct the possible calculation errors. The Evaluation sub-committee shall correct the errors in the following manner:
 - (a) where there is an incoherence between the unit price and the total obtained by multiplying the unit price by the quantity, the unit price being authentic, the total price shall be corrected, unless the Evaluation sub-committee judges that it is a gross error of decimal point in the unit price in which case the total price as presented shall be authentic and the unit price corrected.
 - (b) if the total obtained by addition or subtraction of the totals is not exact, the sub totals shall be considered authentic and the total corrected.
 - (c) where there is a difference between the price indicated in letters and in figures, the amount in letters shall be considered authentic, unless the amount is linked to an arithmetical error confirmed by the sub-detail of the said price, in which case the amount in figures shall prevail subject to paragraphs (a) and (b) above.
- 30.2 The amount featuring in the bid shall be corrected by the Evaluation sub-committee, in accordance with the error correction procedure above and with confirmation by the bidder, the said amount shall be deemed to commit him.
- 30.3 If the bidder who presented the bid evaluated as the lowest refuses the correction thus carried out, his bid shall be rejected and the bid bond may be seized.

Article 31: Conversion into a single currency

- 31.1 To facilitate the evaluation and comparison of bids, the Evaluation sub-committee shall convert the prices of bids expressed in various currencies into those in which the bid is payable in CFA francs.
- 31.2 The conversion shall be done using the selling rate fixed by the Bank of Central African States (BEAC) under the conditions defined by the Special Regulations.

Article 32: Evaluation and comparison of financial bids

- 32.1 Only bids considered as being in compliance, as per the provisions of article 28 of the General Regulations, shall be evaluated and compared by the Evaluation sub-committee.
- 32.2 By evaluating the bids, the Evaluation Sub-committee shall determine for each bid the evaluated amount of the bid by rectifying the amount as follows:
 - a) By correcting any possible error in accordance with the provisions of article 30.2 of the General Regulations;

- b) By excluding projected sums and where necessary provisions for unforeseen occurrences featuring in the bill of quantities and estimates but by adding the amount of works done under State supervision where they are cost in a competitive manner as specified in the Special Regulations.
- c) By converting into a single currency the amount resulting from the rectifications (a) and (b) above, in accordance with the provisions of article 31(2) of the General Regulations;
- d) By appropriately adjusting any other modification, divergence or quantifiable reservation on technical or financial basis.
- e)By taking into consideration the various execution time-limits proposed by the bidders, if they are authorised by the Special Regulations;
- f) If need be, in accordance with the provisions of article 13(2) of the General Regulations and the Special Regulations by applying the rebates offered by the bidder for the award of more than one lot, if this invitation to tender is launched simultaneously for several lots.
- g) If need be, in accordance with the provisions of article 18(3) of the Special Regulations and the Technical Specifications, the proposed technical variants, if they are permitted, shall be evaluated on their own merit and independently of the fact that the bidder offered or not a price for the technical solution specified by the Contracting Authority in the Special Regulations.
- 32.3 The estimated effect of price revision formulae featuring in the GAC and SAC applied during the period of execution of the contract shall not be considered during the evaluation of bids.
- 32.4 If the bid judged the lowest bid is considered abnormally low or strongly unbalanced in relation to the estimates of the Project Owner for the works to be executed in this contract, the Tenders Board may, from the sub-details of prices furnished by the bidder for any element or all the elements of the bill of quantities and estimates, verify if these prices are compatible with the construction methods and proposed calendar. In the case where the justifications presented by the bidder are not satisfactory, the Contracting Authority may reject the bid after the technical opinion of the Public Contracts Regulatory Agency.

Article 33: Preference granted national bidders

National contractors shall benefit from a margin of national preference during the evaluation of bids as provided for in the Public Contracts Code.

Article 34: Award

- The Contracting Authority shall award the contract to the bidder whose bid was judged essentially in compliance with the Tender File and who has the required technical and financial capacities to execute the contract satisfactorily and whose bid was evaluated as the lowest by including, where necessary, proposed rebates
- 34.2 If, according to article 13(2) of the General Regulations, the invitation to tender comprises several lots, the lowest bid shall be determined by evaluating this contract with other lots to be awarded concurrently, by taking into account the rebates offered by the bidders in the case of more than one lot.
- Any award of contract shall be made to the bidder fulfilling the technical and financial capacities required resulting from the evaluation criteria and presenting the bid evaluated as the lowest.

Article 35: The right by the Contracting Authority to declare an invitation to tender unsuccessful or cancel a procedure

The Contracting Authority reserves the right to cancel a procedure of invitation to tender after the authorisation of the Minister Delegate at the Presidency in charge of Public Contracts where the bids have been opened or to declare an invitation to tender unsuccessful after the advice of the competent Tenders Board, without any claims being entertained.

Article 36: Notification of award of the contract

Before the expiry of the validity of the bids set in the Special Regulations, the Contracting Authority shall notify the preferred bidder by telecopy confirmed by registered mail or by any other means that his bid was retained. This letter will indicate the amount the Project Owner will pay the contractor to execute the works and the execution time-limit.

Article 37: Publication of results of award and petitions

- 37.1 The Contracting Authority shall communicate to any bidder or administration concerned, upon request addressed to it within a maximum deadline of five (5) days after publication of the award results, the Independent Observer's report as well as the minutes of the award session of the related contract to which shall be attached the evaluation report of the bids.
- 37.2 The Contracting Authority is bound to communicate the reasons for the rejection of bids of the bidders concerned who so request.
- 37.3 After publication of the award results, bids that are not withdrawn within fifteen (15) days shall be destroyed, without any claims for compensation being entertained. Only the copy destined for the body in charge of regulation shall be kept.
- 37.4 In case of petition, it should be addressed to the Public Contracts Authority, with copies to the body in charge of the regulation of public contracts, the Contracting Authority and the chairperson of the Tenders Board concerned.

It must take place within a maximum deadline of five (5) working days after the publication of the results.

Article 38: Signing of the contract

- 38.1 After publication of the results, the draft contract subscribed by the successful bidder is submitted to the Tenders Board for examination and where applicable, to the Minister in charge of Public Contracts for prior endorsement.
- The Contracting Authority has a deadline of seven (7) days to sign the contract from the date of reception of the draft contract examined by the competent Tenders Board and subscribed by the successful bidder and where applicable, the endorsement of the Minister in charge of Public Contracts.
- 38.3 The contract must be notified to the successful bidder within five (5) days of its date of signature.

Article 39: Final Bond

- 39.1 Within twenty (20) days of the notification by the Contracting Authority, the contractor shall furnish the Project Owner with a final bond, to guarantee the complete execution of the works.
- 39.2 The bond whose rate varies between 2 and 5 percent of the amount of the contract inclusive of all taxes, may be replaced by a guarantee from a banking establishment approved according to the instruments in force with the Project Owner as beneficiary or by a joint or several guarantee.
- 39.3 Small and medium-sized enterprises (SME) constituted of national capital and managed by nationals may, in lieu of the guarantee, provide a statutory lien or a bond issued by a banking establishment or first rate financial institution approved in accordance with the instruments in force.
- 39.4 Failure to produce the final bond within the prescribed time limit shall likely cause the termination of the contract under the terms laid down in the General Administrative Conditions.

7.4. Evaluation and comparison of bids

7.4.1.3 Main qualification criteria

The criteria relating to the qualification of candidates could be indicative on the following: The essential criteria are subjected to minima whose detail is given in the Special Tender Regulation (RPAO).

This evaluation shall be done in a purely binary method with a (yes) or a (no) with an acceptable minimum of 80% of the essential criteria taken in account.

ARTICLE 19: PENALTIES FOR DELAY

ARTICLE 30: DOCUMENTS TO BE FURNISHED BY THE CONTRACTOR (Article 49 of the GAC supplemented)

[Specify the deadlines for the transmission of documents as well as those of approval by persons to be designated]

30.1 Programme of works, Quality Assurance Plan and others (to be specified).

a) Within a minimum deadline of [Fifteen (15) days] from the date of notification of the Administrative Order to commence execution, the contractor shall submit in [six (6)] copies for the approval of [Contract Manager after the endorsement of the Project Manager (or Project Engineer] the execution programme of the works, his supply calendar, his draft Quality Assurance Plan and the Environment Management Plan, where applicable.

This programme shall be exclusively presented according to the furnished models.

Two (2) copies of these documents will be returned to him within a deadline of fifteen (15) days from the date of reception with:

Either the indication "GOOD FOR EXECUTION";

Or the indication of their rejection including the reasons for the said rejection.

The contractor has eight (8) days to present a new draft. The Contract Manager or the Project Manager then has a deadline of five (5) days to give his approval or possibly make comments. Delay in approving the draft execution schedule shall stay the execution deadline.

The approval given by the Contract Manager or Project Manager does not in any way release the contractor of his responsibilities. Meanwhile, works executed before the approval of the programme shall neither be ascertained nor paid for. The updated and approved schedule will become the contractual schedule.

The contractor shall constantly update on site, a schedule that will take account of real progress of the site. Significant modifications may only be made on the contractual programme upon receiving the approval of the Project Manager. After approval of the execution schedule by the Contract Manager, the latter shall transmit it within five (5) days to the Contracting Authority without staying its execution. However, if important modifications alter the objective of the contract or the nature of the works, the Contracting Authority shall return the execution schedule accompanied by reservations to be lifted within fifteen (15) days of the date of reception.

- b) The Environment Management Plan should bring out notably the choice technical conditions of the site and basic life, conditions of the backfill of the extraction sites and conditions for reinstating the works and installation sites.
- c) The contractor shall indicate in this schedule the equipment and methods which he intends to use as well as the personnel he intends to employ.
- d) The approval granted by the Contract Manager or Project Manager shall in no way diminish the responsibility of the contractor with regard to the harmful consequences which their implementation may cause both towards third parties and the respect of clauses of the contract.

30.2 Execution draft

- a) The execution plan documents (calculations and drawings) necessary for the realisation of all the parts of the structure must be submitted for the endorsement of the [Contract Manager or Project Manager] at most one month (specify the duration which must not exceed one month) prior to the date provided for the commencement of execution of the corresponding part of the structure.
- b) The Contract Manager or Project Manager has a deadline of fifteen (15) days to examine and make known his observations. The contractor then has a deadline of [eight days] to present a new file including the said observations.
- 30.3 In case of the non observance of the approval deadlines of the above documents by the Administration, these documents shall be deemed to have been approved

ARTICLE 31: ORGANISATION AND SAFETY OF SITES (article 50 of the GAC)

- 31.1 Signboards at the beginning and end of each section must be placed within a maximum deadline of (01) one month after the notification of the Administrative Order to commence work.
- 31.2 The contractor shall respect all standard safety measures during the execution and shall clear the site upon completion of the works

ARTICLE 32: IMPLEMENTATION OF STRUCTURES

32.1 The engineer shall within a maximum of five (05) days following the date of notification of the service order to commence work, make himself available to the contractor for the setting out of the structures Commencement of work: Before the commencement of work, the authorizing officer shall convene an enlarged site meeting with the following in attendance:

- The Project Owner(contracting authority)......Chairman
- Contract engineer MINHDU,.....Secretary
- The Divisional Delegate of MINMAP or his representative,......Observer
- The Divisional Delegate of Environment and Nature protection... Member
- The Project Manager CDO;..... Member
- The Divisional Delegate of MINEPAT or his representative;.......Member
- The Contractor or his Representative...... (Member)
- The Divisional Delegate MINDDEVEL or his rep.....member

During this meeting, the commission shall do the following;

- Install the project sign post;
- Indicate the site where the structure will be implanted;
- Verify the harmony between the plans and quantities/cost estimates, and note with recommendations any discrepancies;
- Present the site log-book to the contractor;
- Establish and sign an on-the-spot report (minutes). All the members at the site are expected to sign
 this report with or without stamps and the absence of any member should be indicated in the
 report and his signatory left out.

ARTICLE 33: SUB-CONTRACTING

This jobbing order may give rise to sub-contracts or subsidiary orders with a maximum accord of 30% of the initial jobbing order amount.

However, any recourse to sub-contractors or placing of subsidiary orders shall be subject to the prior authorization of the Contracting Authority. Notwithstanding the recourse to sub-contracting or placing of subsidiary orders, the contracting partner shall be responsible for the execution of all the obligation of the said jobbing order.

ARTICLE 34: WORKS SITE JOURNAL (LOG BOOKS)

- 34.1 The worksite journal shall be systematically jointly signed by the Engineer and the Contractor's representative each site visit.
- 34.2 It is a joint document in a single copy. Its pages shall be numbered and initialed. No page should be removed. The erased or cancelled parts shall be mentioned on the margin for validation.

Article 35: Use of explosives (article 60 of the GAC)

Subject to restrictions or prohibitions possibly stipulated in the SAC, the contractor must take under his responsibility, all the necessary precautions so that the use of explosives is not dangerous to the personnel and third parties and does not cause damage to neighbouring property and structures as well as to the structure forming the subject of the contracting.

CHAPTER IV: ACCEPTANCE

ARTICLE 36: PROVISIONAL ACCEPTANCE (article 67 of the GAC)

36.1 PRE- ACCEPTANCE OPERATIONS

Before the acceptance of the works the contractor shall ask in writing to the control Engineer, to organize a technical visit for pre-acceptance. This visit shall include the following operations.

- > Qualitative and quantitative evaluations of the different works that have been executed.
- > Findings and statement of the unexecuted task envisaged in the present jobbing order.
- Findings relative to the completion of the work
- Findings on the quantity of works that have been effectively realized

These operations shall be subject to a site report drawn up on the field, signed by the following.

- The Contract Engineer...... (Secretary)
- The contracting Authority..... (Member)
- The Contractor or his Representative....... (Member)
- A Controller from MINMAP Bui (Observer)

During this pre-reception, the engineer shall eventually specify the reserves to be lifted and the corresponding works to be effected before the reception. The Engineer shall fix the reception date in collaboration with the chief of service for the contract.

36.2 Acceptance The contractor shall request the Authorizing officer in writing, to schedule and call for the provisional acceptance of the works. The report (minutes) of the Pre- Acceptance shall be attached to the said request. The Authorizing officer shall then fix the date of acceptance in collaboration with the contract Engineer and call for the task by a letter of invitation

The acceptance commission shall comprise:

- The Project Owner(contracting authority)......Chairman
- Contract engineer MINHDU,.....Secretary
- The Divisional Delegate of MINMAP or his representative,......Observer
- The Project Manager CDO;..... Member
- The Contractor or his Representative...... (Member)

The commission shall examine the report of the pre-acceptance and shall proceed to the acceptance. An acceptance report (process - verbal) of the works shall be prepared by the Engineer and sign by all the commission members.

ARTICLE 37: DOCUMENTS TO BE FURNISHED AFTER EXECUTION

- 37.1 The contractor shall furnish within one (1) month after completion of the works three (3) copies of all working documents and drawings as executed, especially those relevant to the maintenance of the works.
- 37.2 A penalty of 30% of the guarantee retention shall be retained in the event where the contractor fails to comply with Article 34.1 above.

ARTICLE 38: GUARANTEE TIME LIMITS

The guarantee period shall be **one** (1) **year** to run from the date of the provisional reception of the works or can be guaranteed by a caution of 100%.

ARTICLE 39: FINAL ACCEPTANCE

Final reception shall take place within a maximum deadline of fifteen (15) days from the date of expiry of the guarantee period in case of no guarantee.

The procedure for final reception shall be the same as for provisional reception.

CHAPTER V: MISCELLANEOUS PROVISIONS

ARTICLE 40: TERMINATION OF THE CONTRACT (article 74 of the GAC)

The jobbing order may be terminated as provided for in Part III Paragraph 2 of Decree No. 2004/275 of 24 September 2004 instituting the Public Contracts Code and equally under the conditions laid down in Articles 74, 75 and 76 of the GAC especially in case of:

- Delay of more than fifteen (15) days in the execution of a Service Order or unjustified stoppage of more than seven (7) calendar days;
- Delay in work resulting in penalties of more than 10% of the amount of the works;
- Refusal to repeat poorly executed works;
- Default by the contractor;

Persistent on payment for services.

ARTICLE 41: FORCE MAJEURE (Unforeseen Circumstances)

If the contractor were to raise the issue of force majeure, the thresholds below which claims shall not be admitted are:

- Rainfall: 200 millimetres in 24 hours;
- Wind: 40 metres per second;
- Flood: decennial flood frequency.

ARTICLE 42: DISAGREEMENTS AND DISPUTES (article 79 of the GAC)

Disagreements and disputes resulting from the execution of this contract may be settled amicably.

Where no amicable solution can be found for a disagreement, it is brought before the competent court in Bui Division of the Republic of Cameroon

ARTICLE 43: DIFFERENCES AND DISPUTES

Any dispute arising from this jobbing order shall be resolved amicably. Failure to arrive at a compromise, the matter shall be referred to the competent court in Bui Division of the Republic of Cameroon.

ARTICLE 44: PRODUCTION AND DISSEMINATION OF THIS CONTRACT

The jobbing order shall be produced by the Contracting Authority and the contractor shall multiply it in Ten (10) copies at his expenses.

ARTICLE 45 AND LAST: ENTRY INTO FORCE OF THIS JOBBING ORDER

This jobbing order shall be regarded as finally concluded after its signature by the Mayor of NKOR- and it shall only come into force after it has been notified to the Contractor

DOCUMENT N°. 5 SPECIAL TECHNICAL CONDITIONS (STC)

SPECIAL TECHNICAL SPECIFICATIONS

1 - AIM OF THE PRESENT DOCUMENT

This project concerns THE MAINTENANCE OF ROADS IN NKOR TOWN THROUGH LABOUR INTTENSIVE APPROACH, BUI DIVISION OF THE NORTH WEST REGION, financed by MINHDU budget for 2025 fiscal year

The denominations used in the present PTSN/CCTP are as follow:

- The Contracting Authority: Mayor Nkor Council.
- The Authorizing Officer: The Mayor Nkor Council..
- The control engineer: The Divisional Delegation of MINHDU for Bui Division.

2 - CONSISTENCY OF WORKS

The works consist of the following operations:

Site installation

Clearing

Earthworks

Concrete works

Other works

These works will be executed in different phases according to the above tasks.

3 - DESCRIPTION OF WORKS

3. 1 - Site installation

These works comprise notably:

Putting in place of a sign-post indicating work in conformity with plans

The renting of a structure and land to serve as the enterprise base.

The realization of tracks, access paths and the platforms of site facilities (the areas of storage of the materials and parking of equipment and vehicles),

The arrangement of a small barrack for the road site,

The means of communication: telephone,

All other arrangement for the good working of the site,

Bringing -in and the folding up of all necessary equipment for the site,

The dismantling and the folding of facilities,

Their possible displacement,

The realization and the maintenance of the areas of installation and execution of the yard,

The physical identification of the adjacent or transverse networks on the road itinerary,

The setting up of means to insure the security of the staff and users, in particular the signalization of the site,

The setting up of means to insure the free access of the residents on foot or with vehicle,

The realization of the necessary possible deviations,

The restoration of the places after execution of works.

Bring aspects of Hygiene/Sanitation and environment

3.2- Bush clearing

Works consist of the maintenance of the surroundings and possibly the recovering of their geometric features (shoulders, ditches and slopes):

Bush clearing, trimming of branches, felling of trees,

Bush clearing and cleaning the ditches, the outlets and the transversal crossings, including the evacuation foreign objects, possible scraping of the shoulders.

3.3- Drainage and structures

Works here will concern:

The construction of new small drainage structures

Laying of box culverts and culvert heads.

3.4- Signalisation, Security, Others

The company shall put in place the indispensable temporary signalisation in respect to the security of the users and the site staff. They will foresee to install all the necessary systems of security and to the respect of speed by the users.

The vertical signalization to be put in place in the case of this project will be compliant to the norms in force in Cameroon.

4 - TECHNICAL REFERENCES

It defines the norms and applicable technical specifications, as well as the methods of execution of works and the putting in place of the materials required.

This present methodology is completed for everything that does not appear in the execution documents, by the following fascicles of the French Ministry of equipment,:

Fascicle no 2: Earthworks,

Fascicle no 4: Supply of gravel and other metals, title i and ii;

Fascicle no 7: Recognition soils,

Fascicle no 62: Techniques, rules of conception and calculation of structures and constructions in reinforced concrete,

Fascicle no 63: Execution and laying of mass concrete. Confection of mortars,

Fascicle no 64: Masonry works for civil engineering structures,

However, other norms other than those mentioned in the present document, provided that these are currently admitted and that they drive to results of equal or superior quality. These norms must be submitted to prior approval of the control engineer with support documents. The control engineering justifies his decision by accepting or by rejecting a norm where necessary.

5- GENERALITIES

5.1Tests

The materials, products and components of construction must be compliant to stipulations of the prescriptions of ratified AFNOR, the applicable norms being those enforce in Cameroon.

5.2.Study tests

The company will do all research and necessary laboratory tests to verify the conformity of the materials, to determine the dosages, the compositions of the mixtures and the concretes, the treatments and the different elements brought in, that permit to answer to the criteria of use to the various materials and the required technical stipulations.

The company will do all the formulation and suitability tests on the composite materials used on the site.

After having done all necessary verification, the control engineer will be able to give his accord in writing or will be able to prescribe a new research or the complementary tests.

5.3. Reception test on materials on the site

The Control engineer is held to realize reception tests according to the limit rates fixed by the CCTP. The results will be presented to the control engineer, who, after having done all necessary verifications will be able to give his written authorization for the use of the material concerned, the control engineer reserves the right to ask for any supplementary tests at the Company's expenses or to achieve all verifications judged necessary with the Company's equipment or calling on a specialized and tests accepted laboratory.

The non-exhaustive list of the reception tests on materials is as follows:

5.4. Control tests of laying in place of materials

Our company has the obligation to realize his auto —control in accordance with the limit rates foreseen further in this PTSN/CCTP.

The measure of the in -situ density will essentially be sine through the membrane densitometer.

The control of the laying in place of the concrete will be done through the measure of the slump on Abrams cone and by the measure of the resistance to simple compression on 7 days and on 28 days.

However the control engineer reserves the right o make all verifications judged indispensable with his own equipment and to resort to all other means to insure that the putting in place is operated according to the rules of art. He will be able to resort to the measure of the resistance of the concretes on the "sclerometer" or will be able to order the measure of in —situ densities in depth for embankments done in several layers. The Company will be held to do all resumptions ordered by the control engineer.

5.5. Bringing-in of equipment and machines

The Company's will take all necessary steps to insure the delivery of the facilities and the equipment or machine imported is done in compatible delays with the planning f works, and that all arrangements are taken for their fast deployment onsite. This requirement applies in particular to earthwork equipment crushing machines, and those of transportation.

The Company will have to take account:

- Of suggestions due to the bringing-in and the folding up of equipment unto the place of works, and notably those due transportation by use of a carrying trailer truck,
- Of suggestions due to the passage on a road itinerary worked by another contractor.

5.6 Supplying of the materials

Local materials:

The company will choose and visit all local sources of material and will take the necessary arrangements for their purchase and their transportation to the works.

Materials imported:

The company places the orders among the suppliers for the materials to be imported, sufficiently in advance to permit their manufacture, transportation and delivery in time on the site, so that they can be used as foreseen in the calendar of works, he must take account notably of their clearance delays.

5.7 Sites placed at disposal of the company

If, on the basis of the plans and technical documents of the execution file, the company estimates that the sites possibly place at his disposal by the administration are insufficient or badly situated with respect to his own organization, he is held to inquire about the other sites available. In the hypothesis of the company's opinion, where the sites so available remain insufficient or badly situated, he must assure the supplementary land a research, then do the facilities of purchase or hiring before proceeding to their planning. He takes the costs of research, formalities and preparation of these lands, in change, in view of the establishment of his facilities and areas of storage, and of the preparation of the borrow pits.

The implantation and the planning of these lands must be approved by the control engineer who cannot refuse them without valid reason.

Whatever is the company's choice as for the implantation of these sites for site facilities, areas of storage or borrow pits, they stay entirely responsible for the completion of works on the time foreseen.

5.8 Transportation of heavy equipment

The company will take into account the possible limitations of loads on the roads and existing bridges. He is held to load the equipment n trailers of multiple axles in order to assure the distribution of the total load respecting the limits prescribed by the code of the Road.

5.9 Transportation of materials

The control engineer can proceed at all times to verifications of the loads on the axle of the transportation vehicles. The detentions and the loss of time that result are to the company's charge.

The transportation of the materials is not taken into account if the vehicles doing this transportation are in over-load state.

5.10 Maintenance of the traffic and the local accesses

The traffic and the local accesses must be maintained during the whole duration of the works. The company's arranges access ramps reasonably leveled and crossing the pavement works so as to allow vehicles and pedestrians to cross over.

The deviations for the circulations of vehicles and pedestrians are reduced as far as possible and carefully maintained at the company's charge.

5.11 Bad weather, suspension of works

It belongs to the company's to know, every week rainfall data of the pas weeks.

The control engineer will be able to prescribe, by service order, the suspension of works due to bad weather without the company's raising a complaint of this fact.

In this case, the contractual delay will be prolonged of as many calendar days that will have flowed out between the date of the suspension of works and the date of resumption of works, provided that it is foreseen in the service order.

6 - SITE REGISTER AND MEETINGS

A site register will be held by the site foreman and will be put at the disposal of the control engineer and his representatives.

The following will be written on the site register:

The advancement of works

the relative administrative operations to the execution or to the payment of the works (notification, report of works, etc.);

the atmospheric conditions;

the reception of materials and approvals of all sort given by the control engineer;

the incidents or details of all sort presenting some interests on the point of the ulterior quality of structures, of the real duration of works;

The company can put down incidents or observations liable to lead to a complaint of his part;

The site register will be signed contradictorily by the control engineer and the site foreman at every site meeting.

For every company's possible complaint, no state of events will be made except those or documents mentioned in due time in the site register.

7- PROGRAM OF WORKS

The program of work will specify:

The description of arrangements and methods considered for the execution of works.

The materials used

The key staffs of the direction of the site

The planning of execution

All information that could be useful to the control engineer to organize the controls,

The program will be reviewed during the execution as much as there will be need.

8 - AS-REALIZED-PLANS

We will provide, to the control engineer, in 5 copies, as-realized-plans (plans derécolement) of the works done latest on the date of the provisional reception of works.

These plans are presented under the form of road itinerary mentioning localization, the nature, the quantities, the dates of execution of all realized operations.

II: SOURCE, QUALITY AND PREPARATION OF THE MATERIALS

9 - SOURCE OF THE MATERIAL

We will choose borrow pit sites and should submit them to the approval of the control engineer whose refusal will be worth obligatory to the company to search for new borrow pit sites without any pretension of any indemnity.

When the borrow pit sites chosen by the company have been accepted, he should make a sufficient number of trial pits there and to present to the control engineer.

The company will not be allowed to begin to exploit the identified quarry site except after the control of quality will be done by the control engineer.

The control engineer will stop the exploitation at all times as soon as the extraction chamber is no more giving materials of good quality, by this the company shall not be capable to pretend for any indemnity. The bush clearing, the scraping of the vegetable soil and the discovery, the felling of trees required for the exploitation of the borrow pit are to the company's charge and shall not give right to any explained remuneration.

The former borrow pit sites shall not be exploited again except the company gives proofs that there subsist more materials having the requisite characteristics.

10 - QUALITY CONTROL

The company will consult a road laboratory allowing him to do the internal control needed. This laboratory will be equipped with all instruments, tools and materials and so long as the necessary competent staff to the realization of the tests and study foreseen in the present CCTP will be present. The control engineer or his Representative shall have free access to its facilities.

11 - QUALITY OF THE MATERIALS

11. 1 Current fill rubbles

It concerns fill rubbles realized in the zones without specific problem.

The materials used for the current fill rubbles will come from the general rubbles when they exist or from borrow pits accepted by the control engineer.

They will be deprived of plant or organic matters. They will possess the minimum road requirements necessary.

11.2 Materials for substitution of fill rubbles in swampy zones

The material of substitution to be use in swampy zones will be a material insensible to water, capable to preserve its bearing capacity in a state of saturation and not liable to provoke capillary risings.

Where these materials are lacking, we can use an all-in-ballast rubbles.

11.3 Materials for fills in zone of purge and mess ground (swamps)

One will use the same materials as that for Current fill rubbles.

11.4Materials for fills linked to drainage structures

The material for fills linked to drainage structures and culverts will be a material insensible to water, capable to preserve its bearing capacity in a state of saturation and not liable to provoke capillary risings.

Where these materials are lacking, we can use an all-in-ballast rubbles.

11.5 Materials for spot re-gravelling of the road

The materials for spot re-gravelling of the road will be a material insensible to water, capable to preserve its bearing capacity in a state of saturation and not liable to provoke capillary risings.

Where these materials are lacking, we can use and all-in-ballest rubbles.

The pile of materials presenting characteristics out of the specifications will immediately be evacuated out of the site.

11.5 Materials for mortar, mass concrete and reinforced concrete

Sand:

The Sand will come either from the crusher or from a river. The sand equivalent of the sand will greater than 80% and the percentage of very fine elements eliminated by decantation should be less than 4%.

Sand for mortar:

The proportion of retained elements on sieve 35 (sieve d=2.5 mm) must be more than 10%

Sand for concrete:

The granularity must fit in the spindle (fuseau) below:

The control engineer will require that the sands are washed before their use.

The granularity is controlled by the fine-ness modulus (G/S between 2,2 and 2,8) whose value must not differ of more than 0, 20 in absolute value, the fine-ness modulus of the aggregate for studies.

It will be foreseen a measure of sand for sand equivalent test at delivery of sand on the site.

Aggregates:

The will come from deposits or borrow pits retained by the company and accepted by the control engineer. The aggregates should be clean (% of elements eliminated by decantation less than 2%) and of granulometry adapted to their use.

The maximal proportion in weight of the aggregates destined for quality concretes passing though washing at the sieve 0.5 must be less than 1.5%.

Every granulometric composition is proposed by the companyto the agreement of the control engineer, and same for the composition of the concretes.

The granularity of the aggregates is fixed at:

 For reinforced concretes B 350: 5/25 mm resulting from the mixture of two the classes 5/15 and 15/25

For concretes B 300, B 250 and B 150: 5/40 mm resulting from the mixture of three classes 5/15 and 15/25.

The weight of the retained aggregates sieve corresponding to the superior limit of every granulary class is less than ten percent (10%) of the initial weight submitted for the sifting, and the weight aggregates going through the corresponding sieve by the lower limit is less than five percent (5%) of the initial weight submitted for the sifting.

Mixing Water

The Council shall obtain at his charge clean mixing water for the confection of the concretes. It can, in general, come from water points close to the works or rivers, so long as its quality responds the stipulated conditionals below. Where there is lack, water coming from other sources (bore pits, wells, etc.) can be used.

It must respond to the specifications of the norm NF P 18- 303.

Production for curing

The production for the curing of concrete are submitted to the acceptance of the control engineer by the company, at the time of the study of the composition of the concretes. It is applied to the typical concretes the suitability test. The result of this one conditions the decision of acceptance.

Cement:

They will be of class CPJ 35 depending on the case and will come from an accepted factory.

Steels:

Steels will come from recognized factories and accepted by the control engineer. Their supplying is at the entrepreneur's charge. On request of the control engineer, the company will produce the invoices, the certificates of origin and the result of corresponding tests of the factories or the melting factory of source. The use of the welded bars is forbidden positively. The transportation of steels does not constitute a separated working post leading to a particular remuneration.

The length and the conditions of storage of the steel reinforcement bars must be submitted to the acceptance of the control engineer. These conditions must foresee at the minimum the storage on a floor situated at least 0,30m above the soil, safe from rain, this shelter can be constituted of a tent covering tapeline fibre.

The different types of steels should be separate distinctly FE 400 or FE500, ERL215 or ERL235. Their diameters range from 6-12mm for the present project.

12 - MORTARS AND CONCRETES

The mortar M 400 will be measured at four hundred (400) kilograms of cement per cubic meter of dry sand.

When the thickness of mortar M 400 to be put in place exceeds twenty (20) millimeters, one will use a micro-concrete measured at four hundred (400) kilograms of cement whose composition will be submitted to the prior acceptance of the control engineer.

WAY OF EXECUTING AND ASSESSING THE WORKS

14- GENERAL CONDITIONS OF ASSESSMENT

The works shall be valued by application of the prices of the slip to the really executed quantities, in accordance with the prescriptions. These quantities must be noted and must be approved by the control engineer.

15 - CONSISTENCY OF THE DIFFERENT ASPECTS OF THE WORKS

SITE INSTALLATION

This task shall entail the installation of the Company on the site as describe in the CCTP "mode of execution of works". The effective installation of the company at the site and the folding up of the equipment upon completion of works

BUSH CLEARING

This task consists of cleaning the land and cutting all plants, and the bushes inside the right-of-way out of the roadway in accordance with the directives of the control engineer and to the prescriptions of the present CCTP. This task will normally be executed manually; it could be mechanically, from the request of the control engineer, in the zones of weak population density or in case of particular difficulties.

This price comprises:

- Clearing, the removal of grass, bushes, plantations and vegetation of the right-of-way shoulders,
 lateral ditches and the embankments,
- Felling, the removal of roots of the tees whose diameter is lower to 20 cm,
- The trimming of trees out of the right-of-way,
- The picking-up, the removal, the transportation, the evacuation of the trees, bushes, stumps and their
 evacuation in deposit out of the right-of-way to a place accepted by the control engineer,
- The filling of all holes created by the removal of stumps and trees roots,
- The removal of cleaning products from the ditches, their loading, their transportation accepted by the control engineer,
- All possible indemnities to the residents along the roadway,
- All suggestions linked to the environment.

The quantity to be taken into account, noted contradictorily, is the SQUARE METER (m2) measured horizontally, whatever is the state of each of the two shoulders.

CONSTRUCTION PROPER

This task shall consist the supplying on the work site, the putting place of the box culverts in accordance with typical plans on the tender file, with the execution file and to the specifications of the present CCTP. It comprises notably:

- the supply of all necessary materials for the construction of the culverts
- the implantation and the setting out of the work,
- the possible setting up of a temporary deviation,
- the execution of the excavations in land of all natures and the evacuation of the rubbles to the places
 accepted by the control engineer, and the possible substitution of the foundation seat soil,
- the construction of the culvert base
- the preparation of reinforcement
- the installation and the setting up of the formwork,
- the casting of the structure

- all laying suggestions (water pumping, propping-up) and the taking into account of the differential settlements of the structure,
- the possible cleaning of the upstream opening and downstream of the culvert in order to ensure a
 perfect out-flow of water.
- Connecting adjustments with slopes lower than 4% of the linking point created by the technical block with the existing roadway,
- All suggestions linked in particular to the environmental prescriptions.

These tasks are applied to a LINEAR METER (m1) of culvert laid according to diameter. The lengths to be taken into account will come from approved execution project.

CESSPITS IN REINFORCED CONCRETE FOR CULVERT HEADS

This task involves the execution of cesspits in reinforced concrete for culvert heads in accordance with the typical plans from the tender file, and from the execution project according to the specifications of the present CCTP.

It comprises notably:

- The supply of the materials including the extraction, the manufacture and the selection of aggregates,
 their transportation to the work site,
- The execution of the excavations, whatever is the nature of the land, the loading, the excess rubble transportation whatever is the distance, the discharge in deposits for re-use of final deposit accepted control engineer,
- The production of concrete at 400kg of kilogram per cubic meter and the careful laying of the concrete
- All suggestions linked in particular to the environmental prescriptions.

CULVERT HEADS IN REINFORCED CONCRETE

The task shall comprise the execution of culvert heads in reinforced concrete in accordance with the typical plans from the execution project according to the specification of the present CCTP.

It comprises notably:

The supply of the materials including the extraction, the manufacture and the selection of aggregates, their transportation to the work site,

The execution of the excavations, whatever is the nature of the land, the loading, the excess rubble transportation whatever is the distance, the discharge in deposits for re-use of final deposit accepted control engineer,

The production of the concrete at 400kg kilogram per cubic meter and the careful laying of the concrete in place,

All suggestions linked in particular to the environment prescriptions.

PROTECTION OF THE ENVIRONMENT

16 - SITE INSTALLATION

Our enterprise will propose to the control engineer, before the beginning of the works, the place of his site installation facilities.

The site which must be chosen outside of the sensitive zones, in order to limit the bush clearing, the extraction of bushes, the felling of trees. In the zone of the installation of the site, the trimming of trees branches and the felling of trees of which the diameter measured at 1m from the soil is more than 20 cm will be done after previous agreement with the control engineer.

The site must foresee and adequate drainage of water on the whole of its surface. The maintenance areas and of washing of equipment should be concreted and foresee a cesspool to hold oils and grease. These maintenance areas should have a slope toward a cesspool and toward the inside of the platform in order to avoid the out-flow of polluting products toward the un-covered soils.

At the end of the works, the Council will do all necessary works to the restoration of the places. The Council should fold up all his equipment, engines and materials. He should demolish all stationary installation, as foundation, support made of concrete or metallic, etc. to demolish the concrete areas, to decontaminate the soil as the case may be, either in a general manner to put back the site in its nearest original state. The Council will not be allowed to abandon neither equipment nor materials on the site, nor in the vicinity. For the putting in deposit of demolished materials, the Council must get the approval of the control engineer. The materials are to be covered with a layer of ground, and the site is to receive an adequate drainage in order to avoid all erosion.

17 - OPENING OF THE TEMPORARY BORROW PITS

We shall ask for any necessary authorizations foreseen by the texts and regulations in force:

Law 76/14 of July 8 modified and completed by the one of no 90/021 of August 10, 1990

Decree 88/772 of May 16, 1988 modified by decree 89/674 of April 13, 1989

Decree 90/1477 of November 9, 1990

They will take to his charge all expenses pertaining, including the taxes of exploitation and possible damages expenses to the owners.

In case of the necessity of a new borrow sites, we will ask inevitably for the pre-agreement of the control engineer (verbal note put in the obligatory site report register).

The following criteria must be respected:

distance from the site to be at least 15 m of the road,

distance from the site to be at least 100 m from a river, or from a water plan,

distance from the site to be at least 100 m from dwellings,

surface to be opened limited to the strict minimum

quality trees (to the appreciation of the control engineer) to be preserved and protected.

The areas of deposits should be chosen in order not to embarrass the normal out-flow of waters and should be protected against erosion. The contractor will also get for the areas of deposit at the agreement of the control engineer (obligatory verbal note to be put in the report site register).

If the proposed sites, the method of exploitation and amenities foreseen are not compliant to the environmental instructions, the control engineer shall not give his approval; we will propose other sites, either to modify the method of exploitation, or to propose amenities compliant to instructions, without the us asking for an any indemnity.

We will support all exploitation charges of the borrow pits and notably the opening and the planning of the access tracks of, the bush clearing and the deforestation, the removal of vegetable soil or undesired materials and their putting in deposit out of the limits of the borrow pits, as well as the works of planning concerning the protection of the environment as prescribed.

Our company will execute at the end of works, the necessary works to the restoration of the site. These works will comprise:

the re-establishment of previous natural flow and the planning of offshoot ditches, the suppression of the ruined aspect of the site while eliminating thick rock outcropping blocks.

18 - USE OF BORROW PITS OF PERMANENT CLASS

We will ask for any necessary authorizations foreseen by the texts and regulations in force and should take at his charge all expenses pertaining, including the taxes of exploitation and possible damages expenses to the owners.

During the execution of works:

- the preservation and protection of the trees extraction of materials,
- the works of necessary drainage to protect the materials put in deposits,
- the conservation of the plantations delimiting the borrow pit,
- the maintenance of the access and service tracks.

19 - LOADING AND TRANSPORTATION OF MATERIALS

For all transportation of materials and equipment, whatever they are, conform ourselves to the regulation in force, concerning the restrictions imposed to the weights and sizes of engines and convoys plying the public road network and in particular:

the maximal load per axle, either for simple or per tandem,

the dimensions of the vehicles,

exceptional convoys of dimensions more than norms must make the object of a previous special authorization,

the protective measures of the environment (loss of materials under transportation, dusts),

the entrepreneur must take all necessary arrangements to limit the speed of the vehicles on the site: installation of road sign boards and carriers of signal flags,

regular humidification of the circulation highways in inhabited zones,

foresee deviations toward tracks and existing roads.

We shall put in place an adequate site signalization system for the ongoing of the works.
