#### 2. Nature of services

The works comprise the outcome of the preliminary studies carried out and the detailed information described in the attached cost estimate and the technical specifications.

#### 3. Execution deadline:

The maximum deadline provided by the Project Owner or Contracting Authority for the execution of the works forming the subject of this invitation to tender is **three (03) months** 

#### 4. Lots:

This present Invitation to Tender is made up of two lots; Lot 1 & 2 as seen above. Prospective bidders are therefore requested to specify which Lot they are bidding for and shall be evaluated accordingly.

#### 5. Estimated Cost:

The estimated cost after preliminary studies is 23,000,000 FCFA for Lot 1 and 20,000,000 FCFA for Lot 2 respectively

## 6. Participation and origin:

Participation is open to duly legalized Cameroonian enterprises that fulfill the requirements of this invitation to tender.

## 7. Funding:

Services which form the subject of this invitation to tender shall be funded by the PUBLIC INVESTMENT BUDGET of the Ministry of Agriculture and Rural Development as well as the Ministry of Decentralization and Local Development respectively for the 2025 financial year.

#### 8. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of **four hundred and sixty thousand francs (460,000) FCFA** and **four hundred thousand francs (400,000)** for Lot 1 and Lot 2 **respectively** representing **2% of the project amount** valid for thirty (30) days beyond the date of validity of bids

## 9. Consultation of tender file:

## 12. Admissibility of bids

Under pain of being rejected, only originals or certified true copies from the issuing service or administrative authorities (Senior Divisional Officers, Divisional Officers, etc.) of the documents required must imperatively be produced in accordance with the special conditions of the Invitation to tender. They must not be older than three (03) months.

Any bid not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge of Finance or the non-respect of the models of the Tender File documents shall lead to outright rejection of the bid without appeal.

## 13. Opening of bids:

The bids shall be opened in a single (01) phase on the **07/03/2025 at 10:00am** local time by the KONYE COUNCIL Internal Tenders Board in the Conference Hall of KONYE Council. Only bidders may attend or be represented by a duly mandated person.

## 14. Evaluation criteria

## i. Main Eliminatory Criteria

- In case of absence or non-conformity of an administrative document, the bidder will be given 48 hours to produce or replace the document in question. (nonconformity of administrative documents, technical offers and specifications).
- Antecedents of bad execution of contracts etc. (in conformity with circular letter No.

  failures of companies in the execution of previous contracts in the attribution of new
  contracts.
- The technical score is less than the minimum required;
- It has any fake or forged document;
- Absence of quantified unit price.
- · Absence of bid bond;
- Noncompliance with the model bid documents (Documents 9 and 10).
- It carries any false information.
- Less than 70% of the qualification criteria
